RESOLUTION NO. 308-2021

DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2021 OF MANGALDAN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P3,428,739.88 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2021 involving total appropriations of **P3,428,739.88** which was approved on February 19, 2021 through Appropriation Ordinance No. 2021-03;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of RA 7160 and Article 417 (a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993;
2. The implementation of the Second Tranche Modified Salary Schedule to all municipal officials and employees shall be in accordance with the provisions of Local Budget Circular No. 132 dated January 6, 2021 (Implementation of the Second Tranche of the Modified Salary Schedule for Local Government Personnel pursuant to RA No. 11466); and

3. The Local Expenditure Program (Breakdown of Expenses per Office) should form part of the Appropriation Ordinance.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

NOW, THEREFORE, in view of the foregoing, on motion of SP Members Jeremy Agerico B. Rosario and Liberato Z. Villegas and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare **OPERATIVE IN ITS ENTIRETY the Supplemental Budget for Calendar Year 2021 of Mangaldan, Pangasinan** as of the date fixed therein for its effectivity; provided, that the disbursement of appropriations as approved shall be subject to the existing accounting and auditing rules and regulations, and compliance with other pertinent laws, rules and regulations shall be the responsibility of the Municipal Government of Mangaldan;

RESOLVED FURTHER, that a copy of this resolution be furnished the Office of the Sangguniang Bayan of Mangaldan, Pangasinan, for its information and guidance.
