ORDINANCE AUTHORIZING THE PROPOSED BORROWING OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN, IN THE AMOUNT OF ONE HUNDRED FIFTY MILLION PESOS (P150,000,000.00) IN TERM LOAN FINANCING WITH THE LAND BANK OF THE PHILIPPINES TO FUND THE RENOVATION, IMPROVEMENT AND CONSTRUCTION OF THE PUBLIC MARKET.

WHEREAS, Section 5 (c) of 7160, otherwise known as the Local Government Code of 1991 provides for the general welfare provision in this code shall be liberally interpreted to give more powers to local government units in accelerating economic development and upgrading the quality of life of the community;

WHEREAS, the Municipality of Mangaldan, Pangasinan has already accomplished its initial step of its quest to uplift the economic development of people by providing them with basic facilities and services such as but not limited to Renovation, Improvement and Construction of Public Market;

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan passed and approved Resolution No. 2020 – 217, "Authorizing the Local Chief Executive, Mayor Marilyn DG. Lambino, on behalf of the Local Government Unit of

Mangaldan, Pangasinan, to negotiate a Loan Agreement with the Land Bank of the Philippines in the amount of One Hundred Fifty Million Pesos (P150,000,000.00) subject to the terms and conditions of the Omnibus Term Loan Facility;

WHEREAS, on January 29, 2021, the Office of the Municipal Mayor endorsed to the Sangguniang Bayan a proposed legislative measure Authorizing the proposed borrowing of the Municipality of Mangaldan, Pangasinan in the amount of One Hundred Fifty Million Pesos (P150,000,000.00) to fund the Renovation, Improvement and Construction of Public Market. Consequently, a Committee Hearing was conducted on February 5, 2021 purposely to discuss matters appurtenant to the said borrowing. After careful study and thorough deliberation, the parties concerned agreed to satisfy all the requirements needed for the perfection of the transaction;

WHEREAS, after compliance and submission of all the requirements set forth by law with the second endorsement issued by the Local Chief Executive relative to the proposed borrowing of the Municipality of Mangaldan, Pangasinan with the Land Bank of the Philippines, the Sangguniang Bayan unanimously decided to consider the measure;

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of Mangaldan, Pangasinan in session duly assembled that:

SECTION 1. The Municipal Mayor, in representation of the Municipality, herein after referred to as the "Municipality," is hereby authorized to enter into Loan Agreement with Land Bank of the Philippines, Pangasinan Lending Center in accordance with Section 297 of Republic Act No. 7160 or the Local Government Code, in the amount of One Hundred Fifty Million Pesos (P150,000,000.00) under the terms and conditions herein set forth and such other terms and condition as may be agreed upon with any person, corporation or entity for the purpose of funding priority project/s and subject to the requirements under Section 123 Republic Act No. 7653 as implemented by the Bangko Sentral ng Pilipinas Circular No. 402. In this connection, the Municipal Mayor shall have full power and authority to represent the Municipality in negotiating the terms and conditions for the said borrowing and in signing, executing and delivering such agreements contacts, deeds, papers, and documents as may be necessary and proper for the full and total implementation of the authority herein granted;

SECTION 2. The said priority projects herein specified as the RENOVATION, IMPROVEMENT AND CONSTRUCTION PUBLIC MARKET are socio-economic development projects in accordance with the approved local development plan and public investment program for the period 2020-2025 or for the current year 2021 of the Municipality of Mangaldan.

SECTION 3. Consistent with covering loan contract, deeds and assignment mortgage contracts, and such other agreements as maybe entered into by the Municipality in connection with the borrowing, the features, terms and conditions shall be as follows and are hereby approved:

SECTION 6. This Ordinance shall take effect upon its publication and compliance with all procedures required under Republic Act No. 7160 of an ordinance for its validity, including the affixation of signatures of all the Sangguniang Bayan members, in concurrence thereto, on all the pages of this Ordinance.
