## RESOLUTION NO. <u>2022 - 03</u>

RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. MARY MARILYN DG. LAMBINO AND THE ACTING MUNICIPAL TREASURER, MRS. MARILOU M. GAVINO, TO APPLY WITH LAND BANK OF THE PHILIPPINES (MANGALDAN BRANCH) THE REACTIVATION OF DORMANT ACCOUNTS OF THE MUNICIPALITY.

WHEREAS, Section 444 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, "the Local Chief executive shall, upon authorization of the Sangguniang Bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance";

WHEREAS, the Honorable Municipal Mayor and Acting Municipal Treasurer, in their endorsement letter dated January 6, 2022, requested for the reactivation of the following dormant accounts of the Municipality of Mangaldan with Land Bank of the PhilippinesMangaldan Branch, as follows:
