
RESOLUTION NO. 2022 – 03

RESOLUTION AUTHORIZING THE LOCAL CHIEF
EXECUTIVE, HON. MARY MARILYN DG. LAMBINO AND THE
ACTING MUNICIPAL TREASURER, MRS. MARILOU M.
GAVINO, TO APPLY WITH LAND BANK OF THE PHILIPPINES
(MANGALDAN BRANCH) THE REACTIVATION OF
DORMANT ACCOUNTS OF THE MUNICIPALITY.

WHEREAS, Section 444 (b)(1)(vi) of Republic Act No. 7160, otherwise
known as the Local Government Code of 1991, “the Local Chief executive shall,
upon authorization of the Sangguniang Bayan, represent the municipality in all its
business transactions and sign on its behalf all bonds, contracts, and obligations,
and such other documents made pursuant to law or ordinance”;

WHEREAS, the Honorable Municipal Mayor and Acting Municipal
Treasurer, in their endorsement letter dated January 6, 2022, requested for the
reactivation of the following dormant accounts of the Municipality of Mangaldan
with Land Bank of the PhilippinesMangaldan Branch, as follows:

Current Account No. 4032-1000-02;
Current Account No. 4032-1001-00; and
Current Account No. 4032-1000-45



WHEREAS, the above accounts have not executed any bank transactions and were tagged as dormant accounts; activating the same will give way to the accommodation of bank transactions the Municipal Government of Mangaldan may have in the future;

WHEREAS, finding the request to be meritorious and not contrary to law, this Honorable Body interposes no objection on the above request;

WHEREFORE, on motion of Councilor Atty. Fernando Juan A. Cabrera, duly seconded by all other members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan, authorizes the Local Chief Executive, Hon. Mary Marilyn DG. Lambino and the Acting Municipal Treasurer, Mrs. Marilou M. Gavino, to apply with Land Bank of the Philippines (Mangaldan Branch) the reactivation of dormant accounts of the Municipality;


