RESOLUTION NO. 2022 - 11

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR,
HON. MARY MARILYN DG. LAMBINO TO EXTEND THE
DEADLINE OF PAYMENTS OF MAYOR'S PERMIT AND
OTHER FEES AND CHARGES FROM JANUARY 20, 2022
UNTIL THE CLOSE HOUR OF FEBRUARY 15, 2022 IN THE
MUNICIPALITY OF MANGALDAN, PANGASINAN.

WHEREAS, pursuant to Section 167 of R.A. 7160 otherwise known as the
Local Government Code of 1991 and Article 255 of its Implementing Rules and
Regulations, all taxes, fees and charges due and accruing to the Local Government
Units shall be paid within the first twenty 20 days of January or of each subsequent
quarter, as the case may be. The Sangguniang Bayan concerned may for a
justifiable reason or cause extend the time of payment of such taxes, fees or charges
without overcharges or penalties but only for a period of not exceeding six (6)
months;

WHEREAS, COVID-19 pandemic has sustained its risk of further global
spread and its negative impact on the health and economy of the people;

WHEREAS, the effect of COVID-19 pandemic remains to be in existence,
thus the non-essential businesses, tax payers and the like are to be continuously

affected as their compliance to the order of the government in the combat of these monstrous endemic is required. Ostensibly, people are continuously experiencing income losses;

WHEREAS, taking into consideration the above mentioned reasons and the time constraint in the payment of Mayor's Permit, Fees or Charges, the Municipal Government deemed it proper and necessary to extend the deadline of such payment to avoid the imposition of overcharges or penalties to the concerned citizens;

WHEREAS, Section 444 of the same R.A. 7160 provides that upon authorization of the Sangguniang Bayan, the Local Chief Executive may represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents made pursuant to law or ordinance;

WHEREFORE, on motion of Councilor Juvy O. Frialde and Councilor Fernando Juan A. Cabrera, Chairman, Committee on Ways and Means duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan extend the deadline of renewal of Business Permits until the close of office hours of February 15, 2022 in the Municipality of Mangaldan;

RESOLVED FURTHER, that copies of this resolution be furnished the Office of the Municipal Mayor, Hon. Mary Marilyn DG. Lambino, the MPDC, Mrs. Milagros J. De Guzman, Audit Team Leader and all other authorities concerned for their information and favorable action.
