RESOLUTION NO. 2022 - 14

RESOLUTION REQUESTING HON. MAYOR MARY  
MARILYN DG. LAMBINO TO PROVIDE PARKING SLOTS  
FOR TRICYCLE OPERATORS AND DRIVERS  
ASSOCIATION (TODA) IN THE MUNICIPALITY OF  
MANGALDAN, PANGASINAN.

WHEREAS, it is hereby declared the policy of the state to promote the  
general welfare, particularly the protection and security of its inhabitants;

WHEREAS, Section 447 of Republic Act No. 7160, otherwise known as  
the Local Government Code of 1991 provides for the Powers, Duties and Functions  
of the Sangguniang Bayan such as:

- a. Regulate the uses of streets, avenues, alleys, sidewalks, bridges, parks  
and other public places and approve the construction, improvement,  
repair and maintenance of the same; establish public vehicle terminals  
or regulate the use of the same by privately-owned vehicles which serve  
the public. (5) (v) of R.A. 7160;
- b. Regulate traffic on all streets and bridges, prohibit the putting up of  
encroachments or obstacles thereon, and, when necessary in the interest

of public welfare, authorize the removal of encroachments and illegal constructions in public places;(5) (vi) of R.A. 7160.

WHEREAS, the Sangguniang Bayan on its regular session last January 21, 2022, a dialogue was conducted by the Committee of Public Utilities and Transportation pertaining on concern of tricycle operator and drivers association of Barangays Bantayan, Bateng, Talogtog and other concern Barangays;

WHEREAS, the uncontrolled increase of vendors and unauthorized private vehicles had occupied the dedicated TODA parking slots of the concerned barangays and traffic problems affecting the minor roads causing inconvenience to public vehicles;

WHEREAS, the association of operators and drivers of tricycle association clamored to designate Arellano Street for their parking slots for their convenience and accessibility to their regular passengers and to thrive more income for their family;

WHEREFORE, on motion of Councilor Joel C. Meneses, Chairman Committee on Public Utilities and Transportation duly seconded by all other members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan requests Hon. Mayor Mary Marilyn DG. Lambino to provide parking slots for Tricycle Operators and Drivers Association (TODA) in the Municipality of Mangaldan, Pangasinan, to wit:

**A. One Side Parking for PRIVATE VEHICLES ONLY/designated parking zones.**

1. Serafica St. (Right side from Senior Citizen Building to corner P. De Guzman St. (SB Drive) facing South direction).
2. SB Drive (Northside facing West).
3. Golea St. (facing south from front of Lights Avenue to the Gabilan's residence).

**B. One Side Parking for Motor Tricycles only/designated parking zones. A minimum of Five (5) tricycles per association shall be allowed to park and others should park in their designated waiting area.**

1. Golea (formerly Arellano St.) Bateng East-West TODA, Talogtog TODA, Bantayan TODA, Parian TODA, Pogo TODA, Salay TODA, Macayug TODA, Inlambo TODA.
2. Biagtan St. (near St. Joseph Drug Store) BAB TODA, AGA TODA, DA TODA, LA TODA, MAASIN TODA. (Note: TODA not being accommodated in Biagtan St. but supposed to park in the area are allowed to stay along Frianeza Ext.).
3. FRIANEZA Extension. (GUESANG TODA, OSNATODA, GUEGUESANG TODA).
4. Ydia St. Bari-Malabago-Anolid (BMA) TODA.
5. Biagtan (in front Cuevas Bakery) Salaan TODA, Lanas TODA, Palua TODA, Tebag TODA, Navaluan TODA, Guiguilonen-Embarcadero TODA, Nibaliw TODA.



**C. One Side Parking for Pedicabs and Electric light bike or vehicle only/designated parking zones.**

1. J.L. De Guzman (South Side-Facing West) beside Dunkin Donut. Only 5 Pedicabs and Electric light are allowed to park at a given time.
2. Justice Jimenez St. (North Side -Facing West) Only 5 Pedicabs and Electric light are allowed to park at a given time.
3. Magno St. (North Side -Facing West) Only 5 Pedicabs and Electric light are allowed to park at a given time.
4. Estayo St. (North Side -Facing West) Only 5 Pedicabs and Electric light are allowed to park at a given time.
5. Zamora St. (Back of STCS) (West Side-facing South). Only 5 Pedicabs and Electric light are allowed to park at a given time.
6. Frianeza St. Extension. (Eastside-facing North). Only 5 Pedicabs and Electric light are allowed to park at a given time.
7. Biagtan St. (Southside-Facing West) Only 5 Pedicabs and Electric light are allowed to park at a given time.
8. Arellano St. corner Biagtan St.
9. Cherished Moments School.
10. In Front Amigo Gas Station.
11. In Front Jayo.
12. Beside Mercury Drug (Formerly Magic PODA).
13. CSI PODA.
14. Frianeza St. (Beside Pavilion).


