RESOLUTION REMANDING BARANGAY RESOLUTION NO. 27, SERIES OF 2021, "APPROVING THE ANNUAL INVESTMENT PLAN BARANGAY POBLACION, OF MANGALDAN, PANGASINAN", AND "BARANGAY APPROPRIATION ORDINANCE NO. 02, S. 2021 OF BARANGAY POBLACION, MANGALDAN, PANGASINAN WITH THE TOTAL AMOUNT OF SEVEN MILLION SIX HUNDRED SEVENTY-ONE THOUSAND EIGHT HUNDRED PESOS AND 08/100 (P7,671,800.08)".

WHEREAS, Article III, Section 447, (a) (1) (i) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides: "Xxx. Xxx (underlining score)" Review all ordinances approved by the Sangguniang Barangay and Executive Orders issued by the Punong Barangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Punong Barangay;

WHEREAS, Section 333 (a) of the same code provides: "xxx. The Sanggunian concerned shall have the power to review such ordinance in order to ensure that the provisions of this Title are complied with";

WHEREAS, on January 19, 2022, the Sangguniang Barangay of Poblacion, Mangaldan, Pangasinan submitted two (2) proposed measures, namely: 1. Barangay Resolution No. 27, Series of 2021, "Approving the Annual Investment Plan of Barangay Poblacion, Mangaldan, Pangasinan; and 2. Barangay Appropriation Ordinance No. 02, S. 2021 of Barangay Poblacion, Mangaldan, Pangasinan with the total amount of Seven Million Six Hundred Seventy-One Thousand Eight Hundred Pesos and 08/100 (P7,671,800.08);

WHEREAS, the Sangguniang Bayan conducted Committee Hearing last January 28, 2022 to discuss matters pertaining to the veracity of the two proposed budgetary measures of Barangay Poblacion, Mangaldan, Pangasinan;

WHEREAS, during the deliberation, there were observations raised by the members of the Sangguniang Bayan that were not satisfactorily answered by the members of the Sangguniang Barangay of Poblacion. In line with this, Councilor Joel C. Meneses moved for the deferment of the review and requested the parties to submit pertinent documents relative to their review of the Annual Investment Plan (AIP) and the Annual Budget of Barangay Poblacion, Mangaldan, Pangasinan;

WHEREAS, the Honorable August Body agreed as the hereby agreed to remand the twin proposed measures pending the submission of the requested documents for their perusal in furtherance of their review;

WHEREFORE, on joint motion Councilor Atty. Joseph Emmanuel B. Cera and Councilor Joel C. Meneses and duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan remands Barangay Resolution No. 27, Series of 2021, "Approving the Annual Investment Plan of Barangay Poblacion, Mangaldan, Pangasinan" and "Barangay Appropriation Ordinance No. 02, S. 2021 of Barangay Poblacion, Mangaldan, Pangasinan with the total amount of Seven Million Six Hundred Seventy-One Thousand Eight Hundred Pesos and 08/100 (P7,671,800.08)";
