RESOLUTION AUTHORIZING THE 2022 ANNUAL BUDGET OF BARANGAY NAVALUAN IN THE AMOUNT OF SIX MILLION FOUR HUNDRED SIXTY EIGHT THOUSAND SIX HUNDRED NINETY NINE PESOS (P6,468,699.00) OPERATIVE FOR THEIR OPERATIONS COVERING THE FISCAL YEAR 2022 AS CONTAINED IN THEIR APPROPRIATION ORDINANCE DULY APPROVED BY THEIR SANGGUNIANG BARANGAY.

WHEREAS, forwarded to this body is Annual Budget for Fiscal Year 2022 of Barangay Navaluan, Mangaldan, Pangasinan as authorize by the Sangguniang Barangay under their Appropriation Ordinance No. 6;
