
RESOLUTION NO. 2022 - 29

RESOLUTION AUTHORIZING THE 2022 ANNUAL BUDGET OF BARANGAY POBLACION IN THE AMOUNT OF SEVEN MILLION SIX HUNDRED SEVENTY ONE THOUSAND EIGHT HUNDRED PESOS AND 08/100 (P7,671,800.08) OPERATIVE FOR THEIR OPERATIONS COVERING THE FISCAL YEAR 2022 AS CONTAINED IN THEIR APPROPRIATION ORDINANCE DULY APPROVED BY THEIR SANGGUNIANG BARANGAY.

WHEREAS, forwarded to this body is Annual Budget for Fiscal Year 2022 of Barangay Poblacion, Mangaldan, Pangasinan as authorize by the Sangguniang Barangay under their Appropriation Ordinance No. 2;

WHEREAS, pursuant to Section 333 of R.A. 7160, of the Local Government Code of 1991, the Sangguniang Bayan is vested with power to review the barangay ordinance authorizing the annual appropriations in order to ensure that the provisions pertinent therein are complied with;

WHEREAS, during the first Committee Hearing, the Body decided to remand the two Budgetary measures of Barangay Poblacion, Mangaldan, Pangasinan, RE: 1) Barangay Resolution No. 27, Series of 2021, "Approving the





Annual Investment Plan of Barangay Poblacion, Mangaldan, Pangasinan"; and 2) Barangay Appropriation Ordinance No. 02, s. 2021 of Barangay Poblacion, Mangaldan, Pangasinan with the total amount of Seven Million Six Hundred Seventy-One Thousand Eight Hundred Pesos and 08/100 (P7,671,800.08) by reason of the need to submit pertinent documents to the Annual Investment Plan (AIP) and Annual Budget of Poblacion, Mangaldan, Pangasinan as requested by Councilor Joel C. Meneses, to wit: 1) Deed of Conditional Sale of the new Dump Truck; 2) Certificate of Disposal of the old Dump truck from the Commission on Audit (COA) of Mangaldan; 3) Official Receipts of Vehicle's spare parts and its maintenance; and 4) Official Receipts of the payment of gas bought for the vehicle of Punong Barangay Melinda P. Morillo with Plate Number IAC 3712 from the Phoenix Petroleum (following Brgy. Treasurer Emma Cereno's explanation that the June 2021 purchase of Gas in the name of personal vehicle of Punong Barangay was paid out of her own pocket);


WHEREAS, on February 8, 2020, the Sangguniang Bayan was in receipt of a letter of Punong Barangay Melinda P. Morillo with the corresponding explanation relative to the documents she submitted, to wit: 1) Statement from the contractor/supplier Barbara Jane R. Cabrera of BRJC Jhoriel Enterprises as regards to the condition involving the sale of the purchased dump truck; 2.a) The Resolution No. 07, S. 2020 which a resolution made by the Sanggunian Barangay for the disposal of a Mini Dump Truck, more particularly described as follows: Make: Isuzu; Type: Dump Truck; Serial No.: NKR5B8E-7231 1463; Motor No.: 4BE1-324694; Plate No.: RBT 805; Model: 1991; 2.b) The proof of transmittal of the proceeds for the sale of the said vehicle amounting to ONE HUNDRED FORTY THOUSAND PESOS (P140,000.00) to the Bank account of Barangay Poblacion, Mangaldan; 3) The official receipt of vehicle spare parts for the repair of the vehicle brought to Barbara Jane R. Cabrera; and 4) Official Receipt with No. 0040 dated July 5, 2021, for the payment of gas bought by Punong Barangay Melinda P. Morillo for her vehicle with plate number IAC 3712 which was erroneously included in the statement of account of Barangay Poblacion, Mangaldan, Pangasinan and the corrected Statement of Account both issued by Zae Falco Energy Corp.;

WHEREAS, a brief discussion on the documents presented was made. Afterwhich, the Body decided to consider the proposed measure without prejudice of conducting further inquiry in so far as the utilization of the Budget is concerned;

WHEREAS, after thorough discussion/deliberation on the said Budget of Barangay Poblacion, and with the favorable recommendation of the Local Finance Committee, the Sangguniang Bayan found out that the said Budget of Barangay Poblacion is complete in form and substance and found to be in order and had complied with all the budgetary requirements of the Local Government Code of 1991, and in conformity with the Annual Investment Plan of Barangay Poblacion;

WHEREFORE, on joint motion of Councilor Atty. Joseph Emmanuel B. Cera and Councilor Atty. Fernando Juan A. Cabrera duly seconded by other members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the 2022 Annual Budget of Barangay Poblacion in the amount of Seven Million Six Hundred Seventy One Thousand Eight


