RESOLUTION NO. 2022 – 39

RESOLUTION ADOPTING MARCH 4-14, 2022 AS THE DATES
OF MANGALDAN TOWN FIESTA AND PINDANG FESTIVAL
OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN.

WHEREAS, two (2) years ago, His Excellency President Rodrigo Roa Duterte issued Proclamation Nos. 922 and 929 “Declaring a State of Public Health Emergency throughout the Philippines and “Declaring a State of Calamity throughout the Philippines due to Corona Virus Disease 2019” respectively, in connection with the onslaught of Corona Virus Disease 2019 (COVID -19) which was considered by World Health Organization (WHO) as pandemic;

WHEREAS, the COVID-19 pandemic have caused an immense impact on the health and safety of individuals, ensued economic slowdown, and even halted spiritual, cultural and social activities. WHEREAS, Hon. Mayor Mary Marilyn DG. Lambino convened a meeting and attended by municipal officials, employees and committed stakeholders to discuss the conduct of the town fiesta, the dates and the manner of celebrating the festival;

WHEREAS, the Municipal Officials and Employees of Mangaldan, Pangasinan have come up to a common goal in bringing pleasure and happiness to the lives of every individual in their quest to counter the distress they have experienced during the pandemic. Accordingly, they decided to support the conduct of the Mangaldan Town Fiesta and Pindang Festival;


