
RESOLUTION NO. 2022 - 48

RESOLUTION AUTHORIZING THE 2022 ANNUAL BUDGET

FOUR THOUSAND THREE HUNDRED FORTY EIGHT
PESOS AND 87/100 (P9,004,348.87) OPERATIVE FOR THEIR
OPERATIONS COVERING THE FISCAL YEAR 2022 AS
CONTAINED IN THEIR APPROPRIATION ORDINANCE
DULY APPROVED BY THEIR SANGGUNIANG BARANGAY.

with all the budgetary requirements of the Local Government Code of 1991, and in conformity with the Annual Investment Plan of Barangay Bari;


