RESOLUTION AUTHORIZING THE 2022 ANNUAL BUDGET OF BARANGAY BARI IN THE AMOUNT OF NINE MILLION FOUR THOUSAND THREE HUNDRED FORTY EIGHT PESOS AND 87/100 (P9,004,348.87) OPERATIVE FOR THEIR OPERATIONS COVERING THE FISCAL YEAR 2022 AS CONTAINED IN THEIR APPROPRIATION ORDINANCE DULY APPROVED BY THEIR SANGGUNIANG BARANGAY.

WHEREAS, forwarded to this body is Annual Budget for Fiscal Year 2022 of Barangay Bari, Mangaldan, Pangasinan as authorize by the Sangguniang Barangay under their Appropriation Ordinance No. 01;
