RESOLUTION NO. 2022 - 52

RESOLUTION AUTHORIZING THE 2022 ANNUAL BUDGET  
OF BARANGAY BATENG IN THE AMOUNT OF FIVE  
MILLION SIX HUNDRED FIFTY FOUR THOUSAND TWO  
HUNDRED NINETY FIVE PESOS AND 30/100 (P5,654,295.30)  
OPERATIVE FOR THEIR OPERATIONS COVERING THE  
FISCAL YEAR 2022 AS CONTAINED IN THEIR  
APPROPRIATION ORDINANCE DULY APPROVED BY  
THEIR SANGGUNIANG BARANGAY.

WHEREAS, forwarded to this body is Annual Budget for Fiscal Year 2022  
of Barangay Bateng, Mangaldan, Pangasinan as authorize by the Sangguniang  
Barangay under their Appropriation Ordinance No. 01;

WHEREAS, pursuant to Section 333 of R.A. 7160, of the Local  
Government Code of 1991, the Sangguniang Bayan is vested with power to review  
the barangay ordinance authorizing the annual appropriations in order to ensure that  
the provisions pertinent therein are complied with;



WHEREAS, after thorough discussion/deliberation on the said Budget of Barangay Bateng, and with the favorable recommendation of the Local Finance Committee, the Sangguniang Bayan found out that the said Budget of Barangay Bateng is complete in form and substance and found to be in order and had complied with all the budgetary requirements of the Local Government Code of 1991, and in conformity with the Annual Investment Plan of Barangay Bateng;

WHEREFORE, on joint motion of Councilor Atty. Joseph Emmanuel B. Cera and Councilor Atty. Fernando Juan A. Cabrera duly seconded by other members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the 2022 Annual Budget of Barangay Bateng in the amount of Five Million Six Hundred Fifty Four Thousand Two Hundred Ninety Five Pesos and 30/100 (P5,654,295.30) operative for their operations covering the Fiscal Year 2022 as contained in their Appropriation Ordinance duly approved by their Sangguniang Barangay;
