RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO CREATE PERSONS WITH DISABILITY AFFAIRS OFFICE (PDAO) IN THE MUNICIPALITY OF MANGALDAN, PANGASINAN AND FURTHER DESIGNATE A TEMPORARY OFFICER.
