
RESOLUTION NO. 2022 – 57

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO
CREATE PERSONS WITH DISABILITY AFFAIRS OFFICE
(PDAO) IN THE MUNICIPALITY OF MANGALDAN,
PANGASINAN AND FURTHER DESIGNATE A TEMPORARY
OFFICER.

WHEREAS, the Persons with Disability Affairs Office (PDAO) is one of
the mandated offices our laws are implementing in entire archipelago;

WHEREAS, the protection of disability rights is of utmost importance
being observe in several policies and guidelines from both national and local
government;

WHEREAS, Pursuant to Republic Act No. 7277, mentioned that Persons
with Disabilities are part of the Philippine Society, and thus the State shall give full
support to the improvement of their total well-being and their integration into the
mainstream of society;



WHEREAS, further, R.A. No. 10070, ensure that policies, programs and services for persons with disabilities are implemented at the local level for them to fully participate in building an inclusive society for all through the establishment of PDAO;

WHEREAS, PDAO advocates equal opportunity and accessibility of PWDs on programs for education, employment, health, access to government and non-government facilities and sports development;

WHEREAS, it is the mission of the municipal government of Mangaldan, Pangasinan to implement programs and services that would introduced evidence-based and community-based approaches that will be more responsive to residents with disability in line with the good governance agenda of the local government;

WHEREFORE, on motion of Councilor Christopher G. Romero duly seconded by all other members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the Municipal Mayor to create Persons with Disability Affairs Office (PDAO) in the Municipality of Mangaldan, Pangasinan and further designate a Temporary Officer;
