RESOLUTION AUTHORIZING THE 2022 ANNUAL BUDGET OF BARANGAY ANOLID IN THE AMOUNT OF ELEVEN MILLION SIXTY THOUSAND NINE PESOS AND 99/100 (P11,060,009.99) OPERATIVE FOR THEIR OPERATIONS COVERING THE FISCAL YEAR 2022 AS CONTAINED IN THEIR APPROPRIATION ORDINANCE DULY APPROVED BY THEIR SANGGUNIANG BARANGAY.
