RESOLUTION APPROVING BARANGAY RESOLUTION NO. 04, SERIES OF 2022 OF THE SANGGUNIANG BARANGAY OF MANGALDAN, PANGASINAN, **ENTITLED** INLAMBO, "RESOLUTION APPROVING AND ADOPTING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) C.Y. 2022 SUPPLEMENTAL BUDGET NO. 01 FROM THE REVERSION OF FUNDS OF THE 5% GAD (GENDER AND DEVELOPMENT PLAN), BARANGAY ROAD REGRAVELLING, TO INSTALLATIONS OF AND 70% PRE-CALAMITY LUMINOUS LED STREETLIGHTS OF BARANGAY INLAMBO, MANGALDAN, PANGASINAN IN THE AMOUNT OF THREE HUNDRED THIRTY THOUSAND PESOS ONLY (P330,000.00)".

improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, Section 384 of the same Code, mentioned, that as a basic political unit, the barangay serves as the primary planning and implementing unit of government policies, plans, projects, programs, and activities in the community;

WHEREAS, Barangay Council of Inlambo has submitted its Resolution No. 04, Series of 2022 their Annual Investment Program (AIP) CY 2022 Supplemental No. 01 to Sangguniang Bayan for appropriate legislative action;

WHEREAS, the Sangguniang Bayan, as the legislative body, is empowered to enact ordinance, approve resolutions and authorize annual or supplemental fund for the general welfare and in the manner prescribed by law, Section 447 (R.A. 7160);

WHEREAS, this Sanggunian finds the merit of the aforementioned Supplemental Annual Investment Plan and has satisfactorily met the requirements set forth under the law, as certified by the Local Finance Committee, hence, declares feasible and effective:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan approves Barangay Resolution No. 04, Series of 2022 of the Sangguniang Barangay of Inlambo, Mangaldan, Pangasinan, entitled "Resolution Approving and Adopting the Supplemental Annual Investment Program (AIP) C.Y. 2022 Supplemental Budget No. 01 from the Reversion of Funds of the 5% GAD (Gender and Development Plan), Barangay Road Regravelling, and 70% Pre-Calamity to Installations of Luminous Led Streetlights of Barangay Inlambo, Mangaldan, Pangasinan in the amount of Three Hundred Thirty Thousand Pesos only (P330,000.00)";
