RESOLUTION NO. 2020 – 161

RESOLUTION STRONGLY INDORSING TO THE
DEPARTMENT OF BUDGET AND MANAGEMENT FOR
FINANCIAL ASSISTANCE AND SUPPORT IN THE AMOUNT
OF THIRTY MILLION PESOS FOR THE
CONSTRUCTION/INSTALLATION OF SOLAR POWERED
STREET LIGHTS ALONG NATIONAL HIGHWAYS AND
VARIOUS NOTABLE ROAD NETWORK TO BE FUNDED
UNDER THE LOCAL GOVERNMENT SUPPORT FUND-
FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT
UNITS (LGSF-FA TO LGUS).

WHEREAS, pursuant to Article II, Section 5 of the 1987 Philippine
Constitution, “the maintenance of peace and order, the protection of life, liberty,
and property, and the promotion of the general welfare are essential for the
enjoyment by all the people of the blessing of democracy;

WHEREAS, Section 16 of the Local Government Code of 1991, under
General Welfare Act, states that “every Local Government Unit shall exercise the
powers expressly granted, those necessarily implied therefrom, as well as powers
necessary, appropriate, or incidental for its efficient and effective governance, and
those which are essential to the promotion of general welfare. Within their

respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance right of the people to a balance ecology, encourage and support development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants”;

WHEREAS, the officials and employees of the Municipality of Mangaldan, Pangasinan is cognizant on the commitment of the National Government in helping every Local Government Unit attain its aspiration to extend quality service to the people;

WHEREAS, the Local Chief Executive, Hon. Mary Marilyn DG. Lambino has identified the construction and installation of Solar Powered Street Lights along National Highways and various notable road network. Accordingly, the proposed project/s are included in the project menu of the LGSF-FA under Special Provision No. 5 of the LGSF in the FY 2019 GAA;

WHEREAS, Solar Powered Street Lights promote safety and security to the community and eco-friendly lighting system. They are independent of the utility grid and consequently lessen operation costs than conventional street lights;

WHEREAS, Section 17 of R.A. 7160, otherwise known as the Local Government Code of 1991 provides: SEC. 17. Basic Services and Facilities. – (a) local government units shall endeavor to be self-reliant and shall continue exercising the powers and discharging the duties and functions and responsibilities of national agencies and offices devolved to them pursuant to this Code. Local Government Units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate or incidental to efficient and effective provision of basic services and facilities;

WHEREFORE, on motion of Councilor Joel C. Meneses and duly seconded by all the remaining present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan strongly indorses to the Department of Budget and Management for financial assistance and support in the amount of Thirty Million Pesos for the Construction/Installation of Solar Powered Street Lights along National Highways and various notable road network to be funded under the Local Government Support Fund-Financial Assistance to Local Government Units (LGSF-FA to LGUs);


