RESOLUTION NO. 2020 – 162

RESOLUTION AUTHORIZING THE LOCAL CHIEF  
EXECUTIVE, HON. MAYOR MARY MARILYN DG.  
LAMBINO TO APPROPRIATE FUNDS TO BE USED IN  
GRANTING THE HAZARD PAY TO QUALIFIED  
FRONTLINERS OF BARANGAY PARTICULARLY THE  
BARANGAY HEALTH WORKERS (BHW), BARANGAY  
TANODS, BARANGAY SERVICE POINT OFFICERS (BSPO)  
AND BARANGAY NUTRITION SCHOLARS (BNS)  
CHARGEABLE AGAINST ASSISTANCE TO BARANGAY  
FUNDS OR ANY AVAILABLE FUNDS OF MUNICIPALITY.

WHEREAS, pursuant to Administrative Order (AO) No. 26 dated March  
23, 2020 authorized the grant of Hazard Pay, to be called as COVID-19 Hazard  
Pay, to government employees and workers engaged through Contract of Service  
(COS) or Job Order (JO) basis who physically report for work during the  
implementation of an Enhanced Community Quarantine;

WHEREAS, there is a need to recognize the heroic and invaluable  
contributions of our public health workers throughout the country, who bravely and  
unselfishly risk their lives and health by being at the forefront of the national effort  
to address the public health emergency;

WHEREAS, AO No. 26 is in accordance with Congress Joint Resolution No. 4 dated June 17, 2009 which authorizes the grant of Hazard Pay to government personnel exposed to hazardous situation, such as, but not limited to, disease-infected places, which pose occupational risks or peril to life;

WHEREAS, said benefit shall be granted to the aforementioned government employees and workers since they are inevitably exposed to health risks and hazards during the period of an Enhanced Community Quarantine;

WHEREAS, the Local Administration is cognizant to the efforts made by Barangay Officials and Officers particularly the Barangay Health Workers, Barangay Tanods, Barangay Service Point Officers and Barangay Nutrition Scholars in the combat against the monstrous COVID-19 in response to the call of the national government;

WHEREAS, the Local Administration is also aware that every barangays of the Municipality of Mangaldan has no sufficient funds to shoulder the Hazard Pay of their respective Barangay Health Workers, Barangay Tanods, Barangay Service Point Officers and Barangay Nutrition Scholars;

WHEREFORE, on joint motion of Councilor Joselito G. Quinto, Chairman, Committee on Health, Nutrition and Sanitation and Councilor Atty. Joseph Emmanuel B. Cera, Chairman, Committee on Appropriations duly seconded by all members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the Local Chief Executive, Hon. Mayor Mary Marilyn DG. Lambino to appropriate funds to be used in granting the Hazard Pay to qualified Frontliners of barangay particularly the Barangay Health Workers (BHW), Barangay Tanods, Barangay Service Point Officers (BSPO) and Barangay Nutrition Scholars (BNS) chargeable against Assistance to Barangay Funds or any available funds of Municipality;

RESOLVED FURTHER, that copies of this resolution be furnished the Office of the Local Chief Executive, Hon. Mayor Mary Marilyn DG. Lambino, the Municipal Budget Officer, Mrs. Julieta C. Petonio, the Municipal Treasurer, Mrs. Maria Alicia C. Mejia, the MPDC, Mrs. Milagros J. Padilla, the MLGOO, Mrs. Romarie P. Soriano, the Commission on Audit through Mrs. Marina P. De Guzman, Audit Team Leader and all other authorities concerned for their information and favorable action.




