RESOLUTION AUTHORIZING THE LOCAL CHIEF
EXECUTIVE MARY MARILYN DG. LAMBINO TO ENTER
ANEW INTO A MEMORANDUM OF AGREEMENT (MOA)
WITH URDANETA WASTE MANAGEMENT REPRESENTED
BY MR. MARK ANTHONY V. AGSALUD, GENERAL
MANAGER, FOR PROPER DISPOSAL OF SOLID RESIDUAL
WASTES OF THE MUNICIPALITY OF MANGALDAN IN ITS
ENGINEERED SANITARY LANDFILL LOCATED AT SITIO
CALEGU, BARANGAY CATABLAN, URDANETA CITY,
PANGASINAN AND FURTHER GIVE HER AUTHORITY TO
AMEND, REVISE, OR MODIFY THE TERMS AND
CONDITIONS SET FORTH IN THE MEMORANDUM OF
AGREEMENT (MOA) PREVIOUSLY ENTERED BY THE
MUNICIPALITY.

WHEREAS, the Municipality of Mangaldan, Pangasinan has an existing
Contract with the Urdaneta Waste Management, by virtue of Resolution No. 2019 -
86;

WHEREAS, the Local Government Unit of Mangaldan, Pangasinan is
continuously focusing its concern on waste management so as to comply with the

mandate of the national government to protect the environment for the welfare of the future generation;

WHEREAS, the current administration desires and intends to continue to avail the services of hauling and disposal of waste/garbage offered by Urdaneta Waste Management and is willing to abide with provisions imposed and agreed by both parties;

WHEREAS, pursuant to Section 444 (b) (1) (vi) of the Local Government Code of 1991 otherwise known as R.A. 7160, the Municipal Mayor shall, upon the authorization by the Sangguniang Bayan, represent the Municipality in all its business transactions and sign on its behalf all bonds, contracts and obligations, and such other documents made pursuant to law or ordinance;

WHEREFORE, on the motion of Councilor Aldrin O. Soriano duly seconded by the remaining members present:

RESOLVED, as it hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the Local Chief Executive Mary Marilyn DG. Lambino to enter anew into a Memorandum of Agreement (MOA) with Urdaneta Waste Management represented by Mr. Mark Anthony V. Agsalud, General Manager, for proper disposal of solid residual wastes of the Municipality of Mangaldan in its Engineered Sanitary Landfill located at Sitio Calegu, Barangay Catablan, Urdaneta City, Pangasinan and further give her authority to amend, revise, or modify the terms and conditions set forth in the Memorandum of Agreement (MOA) previously entered by the municipality;


RESOLVED FURTHER, that copies of this resolution be furnished to the Urdaneta Waste Management through Mr. Mark Anthony V. Agsalud, General Manager, the General Services Office through Mr. Fernando Saguisag A. Cabrera, the Solid Waste Management Focal Person, Mr. Pedrito N. Rivera, the DILG through Mrs. Romarie P. Soriano, MLGOO, the Commission on Audit through Mrs. Marina P. De Guzman, Audit Team Leader, the Office of the Municipal Mayor, Hon. Mary Marilyn DG. Lambino and all other authorities concerned for their information and favorable action.
