RESOLUTION APPROVING AND ADOPTING THE
SUPPLEMENTAL ANNUAL INVESTMENT PLAN (AIP) NO.
4, CY 2020 OF THE MUNICIPALITY OF MANGALDAN,
PANGASINAN.

WHEREAS, the municipal officials and employees of Mangaldan, Pangasinan are always in the frontline in any endeavors of the municipality. Accordingly, even the risk during the height of COVID-19 were addressed carefully by the LGU family and allowed its officials and employees to report to work, subject to corresponding protocols. Moreover, pursuant to Joint Memorandum Circular No. 2019-01 of the DILG-DBM, the Municipality of Mangaldan, Pangasinan were one of the few municipalities of the Province of Pangasinan who were granted the Performance-Based Bonus for Fiscal Year 2019, enough reason to justify our claim of being a performer. Likewise, the Local Administration is giving importance to the Security and Janitorial Services of the municipality and always after the welfare of its personnel;

WHEREAS, the Department of Budget and Management under Budget Circular No. 26 authorizes the grant of hazard pay to be called COVID-19 Hazard

Pay to government employees and workers during the implementation of ECQ in their respective work station;

WHEREAS, the Municipal Development Council, Executive Committee convened a meeting last June 29, 2020 and passed and approved MDC Resolution No. 4, Series of 2020 "*Strongly Endorsing the CY 2020 Annual Investment Program (AIP) Supplemental No. 4 of the Municipality of Mangaldan, Pangasinan.*" The unexpended balances from Vacant Positions in January-June 2020 and Other Personnel Benefits amounting to P8,387,123.68 shall be appropriated for the following identified Priority Programs, Project and Activities, namely: 1.) Hazard Pay for Employees who reported to work during ECQ; 2.) Performance-Base Bonus (PBB) 2019; 3.) Security and Janitorial Services; and 4.) Salary Differential of Mrs. Marilou M. Gavino;

WHEREAS, the Local Chief Executive, Hon. Mary Marilyn DG. Lambino deemed it appropriate to implement the aforementioned Priority Programs, Project and Activities appurtenant to Officials and Employees and to the municipality in reciprocity to the effective, efficient and quality services we are rendering to the public;

WHEREAS, considering the urgency of the Priority Programs, Project and Activities embodied in the Plan and understood to be in conformity with the thrust of the Local Government Unit of Mangaldan, Pangasinan contributing to the welfare of the Officials and Employees of the municipality, the Sangguniang Bayan felt the necessity to approve and adopt the resolution of the Municipal Development Council;

WHEREFORE, on motion of Councilor Atty. Joseph Emmanuel B. Cera duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan approves and adopts the Supplemental Annual Investment Plan (AIP) No. 4, CY 2020 of the Municipality of Mangaldan, Pangasinan;




