RESOLUTION NO. 2020 – 171

AN EN BANC RESOLUTION EARNESTLY IMPLORING  
MAYOR MARY MARILYN DG. LAMBINO ALLOW A  
CALIBRATED NUMBER OF PEDICABS AND MOTOR  
TRICYCLE DRIVERS TO PASS ALONG MANGALDAN'S  
RIZAL AVENUE AS THE MUNICIPALITY IS NOW UNDER  
MODIFIED GENERAL COMMUNITY QUARANTINE.

WHEREAS, MANGALDAN is now under MODIFIED GENERAL  
COMMUNITY QUARANTINE (MGCQ);

WHEREAS, the policy MGCQ is a compromise between public health and  
the reopening of the economy where business would restart provided that social  
distancing and the wearing of face masks would be observed;

WHEREAS, pedicab and motor tricycle drivers and their dependents have  
made known their hardships in earning their daily bread because of the pandemic;

WHEREAS, our people are having a hard time going to the market and carrying what they bought because there are no pedicabs and motor tricycles passing along Rizal Avenue where almost all commercial business including the public market are located;

WHEREAS, the Sanggunian Bayan Members are listening to their pleas while taking into consideration the need to rebuild the economy for the municipality, helping pedicab and motor tricycle drivers earn again following the lockdown and making it more convenient for our people to use public transport and to move to and from our business center;

WHEREAS, Sanggunian Bayan is ready, able and willing to support an Executive Order and later a Municipal Ordinance to implement rules for the conduct of allowing a limited number of these types of transportation;

WHEREFORE, on motion of Councilor Joel C. Meneses duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan earnestly implores Mayor Mary Marilyn DG. Lambino to allow a calibrated number of pedicabs and motor tricycle drivers to pass along Mangaldan's Rizal Avenue as the Municipality is now under Modified General Community Quarantine;

RESOLVED FURTHER, that copies of this resolution be furnished to the DILG through Mrs. Romarie P. Soriano, MLGOO, the Commission on Audit through Mrs. Marina P. De Guzman, Audit Team Leader, the Office of the Municipal Mayor, Hon. Mary Marilyn DG. Lambino and all other authorities concerned for their information and favorable action.


