AN EN BANC RESOLUTION EARNESTLY IMPLORING
MAYOR MARY MARILYN DG. LAMBINO FOR THE
OPENING OF A PORTION OF THE FRONT OF THE PUBLIC
MARKET FOR MARKET-GOERS AS MANGALDAN IS NOW
UNDER MODIFIED GENERAL COMMUNITY
QUARANTINE.

WHEREAS, MANGALDAN is now under MODIFIED GENERAL
COMMUNITY QUARANTINE (MGCQ);

WHEREAS, the policy MGCQ is a compromise between public health and
the reopening of the economy where business would restart provided that social
distancing and the wearing of face masks would be observed;

WHEREAS, a lot of small businesses at the Mangaldan Public Market are
struggling because of the Covid-19 Pandemic;

WHEREAS, ~~there is~~ a humble request from market-goers that they be allowed to enter the ~~front~~ portion of the public market thus giving them greater access to shop for goods ~~and buy~~ food;

WHEREAS, it is also the hope of these small business owners and stall holders of the public market that the same front portion be opened for foot traffic so they would be able to sell their wares and goods;

WHEREAS, the Sanggunian Bayan Members are listening to their pleas while taking into consideration the need to rebuild the economy for the municipality by collecting more revenue, helping business people start again following the lockdown and making it more convenient for our people to go and shop at the Mangaldan Public Market;

WHEREFORE, on motion of Councilor Joel C. Meneses duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan earnestly implores Mayor Mary Marilyn DG. Lambino for the opening of a portion of the front of the public market for market-goers as Mangaldan is now under Modified General Community Quarantine;


