RESOLUTION NO. 2020 – 173

AN EN BANC RESOLUTION EARNESTLY IMPLORING MAYOR MARY MARILYN DG. LAMBINO TO INTERCEDE FOR THE JEEPNEY OPERATORS/DRIVER'S ASSOCIATION OF MANGALDAN (JODMA) TO THE LAND TRANSPORTATION AND FRANCHISING REGULATORY BOARD (LTFRB) IN SEEKING A SPECIAL PERMIT TO ALLOW THE RESUMPTION OF OPERATION AS PUBLIC UTILITY VEHICLES.

WHEREAS, MANGALDAN is now under MODIFIED GENERAL COMMUNITY QUARANTINE (MGCQ);

WHEREAS, the policy MGCQ is a compromise between public health and the reopening of the economy where business would restart provided that social distancing and the wearing of face masks would be observed;

WHEREAS, public transport jeepney drivers have made known their hardships in earning their daily bread because of the pandemic as they have been unable to drive since the lockdown;

WHEREAS, they are seeking the intervention of MAYOR MARY MARILYN DG. LAMBINO to sign a special permit, if legally necessary, to allow them to ply Mangaldan roads once again as public utility jeeps;

WHEREAS, the Sanggunian Bayan Members are listening to their pleas while taking into consideration the need to rebuild the economy for the municipality by collecting more revenue, helping jeepney drivers and operators to start again following the lockdown and making it more convenient for our people to use public transport;

WHEREFORE, on motion of Councilor Joel C. Meneses duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan earnestly implores Mayor Mary Marilyn DG. Lambino to intercede for the Jeepney Operators/Driver's Association of Mangaldan (JODMA) to the Land Transportation and Franchising Regulatory Board (LTFRB) in seeking a Special Permit to allow the resumption of operation as Public Utility Vehicles;

RESOLVED FURTHER, that copies of this resolution be furnished to the Jeepney Operators/Driver's Association of Mangaldan (JODMA) through the President, the DILG through Mrs. Romarie P. Soriano, MLGOO, the Commission on Audit through Mrs. Marina P. De Guzman, Audit Team Leader, the Office of the Municipal Mayor, Hon. Mary Marilyn DG. Lambino and all other authorities concerned for their information and favorable action.


