RESOLUTION NO. 2020 – 174

RESOLUTION APPROVING AND ADOPTING THE MUNICIPAL DEVELOPMENT COUNCIL (MDC) EXECOM RES. NO. 5, S. 2020, REPROGRAMMING PPAs FROM THE 20% DEVELOPMENT FUND 2019 AND PRIOR YEARS OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN.

WHEREAS, the Municipal Development Council, EXECUTIVE Committee passed and approved Resolution No. 5, S. 2020, “Strongly Endorsing the Reprogramming of Programs/ Projects/Activities from the 20% Development Fund 2019 and prior years of the Municipality of Mangaldan, Pangasinan”;

WHEREAS, the Municipal Development Council shall assist the Sangguniang in setting the direction of economic and social development and coordinating development efforts within the territorial jurisdiction of Mangaldan pursuant to the provision of Section 106 of RA 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the local administration is bent on developing the infrastructure facilities of the municipality so as deliver basic services to the people pursuant to the provision of Section 17, par. (a), (b) (2) (viii) of the same RA 7160. Accordingly, the Municipal Development Council, Executive Committee identified

as one of its Projects, Programs and Activities the improvement of Drainage System at Frianeza St. with a length of 673.5m meters;

WHEREAS, the Municipality of Mangaldan, Pangasinan is very fortunate to be one of the grantees of the Assistance to Municipalities (AM) in the amount of Eleven Million Six Hundred Twenty-Three Thousand Pesos only (P11,623,000.00). Nevertheless, the said amount is not sufficient to support the proposed improvement, hence they have source out funds from 20% Development Fund 2019 and prior years and was able to identify and appropriated Six Million Fifty-Two Thousand One Hundred Eighty-Six Pesos only (P6,052,186.81) to complete the projects;

WHEREAS, the Sangguniang Bayan of Mangaldan is cognizant on the candor of the Local Development Council through the Local Chief Executive to implement projects, programs and activities of the municipality that will give comfort and convenience to the public. Accordingly, the same Sangguniang Bayan is always in support to all of these endeavors for the welfare of the people;

WHEREFORE, on motion of Councilor Atty. Joseph Emmanuel B. Cera duly seconded by the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan approves and adopts the Municipal Development Council (MDC) EXECOM Res. No. 5, S. 2020, Reprogramming PPAs from the 20% Development Fund 2019 and prior years of the Municipality of Mangaldan, Pangasinan;
