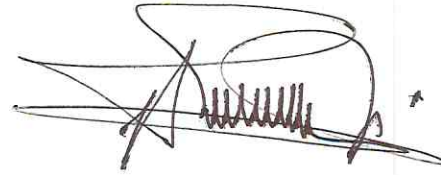

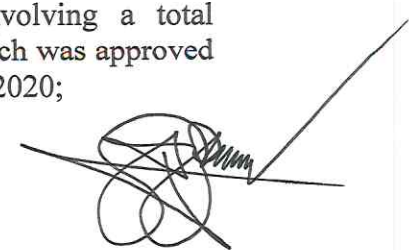

RESOLUTION NO. 2020 – 177

RESOLUTION APPROVING BARANGAY ORDINANCE NO.
2, S. 2020 OF THE SANGGUNIANG BARANGAY OF POGO,
MANGALDAN, PANGASINAN, ENTITLED “AN
ORDINANCE ENACTING SUPPLEMENTAL BUDGET NO. 1
CY 2020 OF THE GENERAL FUND REALIGNING THE
BUDGET FOR THE PURCHASE OF LOT FOR THE
COVERED COURT IN THE AMOUNT OF ONE HUNDRED
THOUSAND PESOS (P100,000.00) FOR FISCAL YEAR 2020
OF THE BARANGAY COUNCIL OF POGO INTO VARIOUS
PROGRAMS.

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local
Government Code of 1991, the Sangguniang Bayan of Mangaldan as a Legislative
Body of the Municipality is empowered to review Ordinances authorizing annual or
supplemental appropriations of Barangays in the manner prescribed by law;

WHEREAS, the Barangay Council of Pogo, Mangaldan, Pangasinan has
submitted its Supplemental Budget No. 1 for CY 2020 involving a total
appropriation of One Hundred Thousand Pesos (P100,000.00) which was approved
on July 2, 2020 through Appropriation Ordinance No. 1, Series of 2020;



WHEREAS, the Committee on Appropriation and the Committee on Laws and Ordinances of the Sangguniang Bayan made an initial review and study on the said resolution and found out that the same was in order and in consonance with the submitted Supplemental Annual Investment Program of the Barangay;

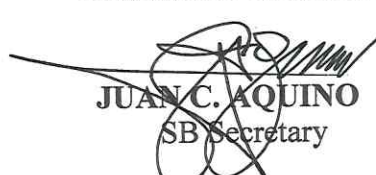
WHEREFORE, on motion of Councilor Atty. Joseph Emmanuel B. Cera duly seconded by the remaining members present:

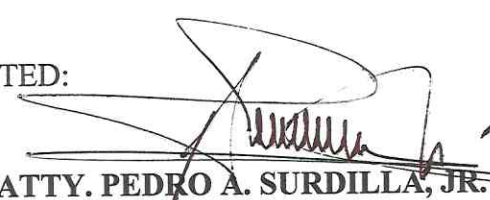
