

RESOLUTION NO. 2020 – 178

RESOLUTION AUTHORIZING THE LOCAL CHIEF
EXECUTIVE, MARY MARILYN DG. LAMBINO, TO ENTER
INTO A MEMORANDUM OF AGREEMENT ON BEHALF OF
THE MUNICIPALITY OF MANGALDAN WITH THE
ENVIRONMENT MANAGEMENT BUREAU-DEPARTMENT
OF ENVIRONMENT AND NATURAL RESOURCES (EMB-
DENR) REGIONAL OFFICE I FOR THE ESTABLISHMENT
OF A FUNCTIONAL AND OPERATIONAL MATERIAL
RECOVERY FACILITY (MRF) WITH THE MANDATED
SEGREGATION AT SOURCE AND SEGREGATED
COLLECTION.

WHEREAS, the EMB-DENR is mandated to monitor and implement the
programs, projects and activities of the municipality relative to the environment
protection and management specifically the solid waste management;

WHEREAS, as provided by R.A 9003, the local government units are given
direct responsibility in the strict implementation of solid waste management,
particularly the safe waste collection, disposal and recovery by establishing
materials recovery facility or sanitary landfill;



WHEREAS, our municipality is deeply grateful as we are chosen to be one of the recipients of the proposed financial assistance from the Environment Management Bureau for the Calendar Year 2020 in the amount of TWO HUNDRED THOUSAND PESOS (P200,000.00) for the establishment of a storage room area for the containment of hazardous waste;

WHEREAS, there is a need to enter into a Memorandum of Agreement (MOA) to fortify the partnership of the Local Government Unit of the Municipality of Mangaldan and EMB-DENR in controlling and regulating the generation, storage, collection and disposal of solid waste within the municipality and promote an orderly and sanitary condition of surrounding;

WHEREAS, as specified in Section 444 of R.A 7160, the Municipal Mayor upon authorization of the Sangguniang Bayan, shall represent the municipality in all business transactions, sign contracts and obligations;


WHEREFORE, on motion of Councilor Aldrin O. Soriano duly seconded by all Sangguniang Bayan Members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the Local Chief Executive, Mary Marilyn DG. Lambino, to enter into a Memorandum of Agreement on behalf of the Municipality of Mangaldan with the Environment Management Bureau-Department of Environment and Natural Resources (EMB-DENR) Regional Office I for the establishment of a functional and operational Material Recovery Facility (MRF) with the mandated segregation at source and segregated collection;

RESOLVED FURTHER, that copies of this resolution be furnished to the Office of EMB-DENR, Regional Office I, the MLGOO, Mrs. Romarie P. Soriano, the Commission on Audit through Mrs. Marina P. De Guzman, Audit Team Leader, the Office of the Municipal Mayor, Hon. Mary Marilyn DG. Lambino and all other authorities concerned for their information and favorable action.
