## **RESOLUTION NO. 2020 – 181**

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. MARY MARILYN DG. LAMBINO TO ALLOW THE USAGE OF THE UNTILED PORTION OF THE PUBLIC PLAZA AS PARKING AREA FOR GOVERNMENT VEHICLES, MUNICIPAL OFFICIALS AND EMPLOYEES VEHICLES AND OTHER PRIVATE VEHICLES.

WHEREAS, pursuant to Section 17(b) (vii) of Republic Act 7160, otherwise known as the Local Government Code, it states that "xxx local government shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities. Further, as embodied under said act par (b) (2) (vii) that "Municipal buildings, cultural centers, public parks including freedom parks, playgrounds, and other sports facilities and equipment, and other similar facilities" could be subjected for basic services and facilities;

WHEREAS, the Local Government Unit (LGU) has its vested power to utilize basic services and facilities for the general welfare of its employees as well as private individuals;

WHEREAS, under the new normal caused by COVID-19 pandemic, the traffic situation including parking area is not on its usual set-up due to restrictions giving observance to the minimum health standard protocols;

WHEREAS, the municipal officials and employees' vehicles and other private vehicles, encounter difficulty in locating legal parking areas thus, causing them to park anywhere violating traffic rules and regulations;

WHEREFORE, on motion duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the Municipal Mayor, Hon. Mary Marilyn DG. Lambino to allow the usage of untiled portion of the public plaza and the Central School playground to serve as parking areas for government vehicles, municipal officials and employees' vehicles and other private vehicles;
