RESOLUTION NO. 2020 – 184

RESOLUTION DECLARING THE SUPPLEMENTAL BUDGET
NO. 01 FOR CY 2020 OF BARANGAY MAASIN,
MANGALDAN, PANGASINAN INVOLVING A TOTAL
APPROPRIATION OF THREE HUNDRED THIRTY THREE
THOUSAND SEVEN HUNDRED TWENTY PESOS AND
87/100 (P333,720.87) OPERATIVE IN ITS ENTIRETY.

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local
Government Code of 1991, the Sangguniang Bayan of Mangaldan as a Legislative
Body of the Municipality is empowered to review Ordinances authorizing annual or

and Ordinances of the Sangguniang Bayan made an initial review and study on the


