
**RESOLUTION NO. 2020 – 185**

RESOLUTION AUTHORIZING THE LOCAL CHIEF  
EXECUTIVE, HON. MARY MARILYN DG. LAMBINO, AND  
ACTING MUNICIPAL TREASURER, MRS. MARIA ALICIA C.  
MEJIA TO EFFECT THE CLOSING OF THE ACCOUNT OF  
THE MUNICIPALITY OF MANGALDAN, PANGASINAN  
WITH POSTBANK AND DEPOSIT ITS PROCEEDS WITH  
THE EXISTING LAND BANK ACCOUNT OF THE  
MUNICIPALITY.

WHEREAS, the Bureau of Local Government Finance has designated Mrs. Maria Alicia C. Mejia as the Acting Municipal Treasurer of the Local Government Unit of Mangaldan, Pangasinan dated March 30, 2020;

WHEREAS, Postbank, Dagupan Branch is one of the depository banks of the Local Government Unit of Mangaldan, Pangasinan and has an existing Account Number 0004-0017-231;

WHEREAS, Postbank has been converted to Overseas Filipino Bank, thus perceived to have priorities over Overseas Filipino Workers only, hence there is a need to withdraw the remaining deposited amount and further close the said Account;

Mejia to effect the Closing of the Account of the Municipality of Mangaldan, Pangasinan with Postbank and deposit its proceeds with the existing Land Bank Account of the municipality;
