RESOLUTION EARNESTLY REQUESTING HON. RETIRED

WATER AND SEWERAGE SYSTEM (MWSS), THROUGH
ATTY. MELANIE SIA-LAMBINO, MEMBER, BOARD OF
TRUSTEES (MWSS) FOR THE DONATION OF TWO (2)
MULTI-PURPOSE UTILITY VEHICLES TO BE USED BY THE
MUNICIPAL GOVERNMENT OF MANGALDAN,
PANGASINAN.

WHEREAS, pursuant to Section 17 of Republic Act No. 7160, otherwise
known as the Local Government Code, it states that “Local Government Units
shall endeavor to be self-reliant and shall continue exercising the powers and
discharging the duties and functions currently vested upon them, and shall likewise
exercise other powers and discharge such other functions and responsibilities as are
necessary, appropriate, or incidental to efficient and effective provision of the basic
services and facilities enumerated therein;

WHEREAS, Section 5 of the Philippine Constitution provides, that “the
maintenance of peace and order, the protection of life, liberty, and property, and
promotion of the general welfare are essential for the enjoyment by all the people
of the blessings of democracy”;

WHEREAS, the Local Government Unit of Mangaldan, in its endeavor to provide better services and facilities to its constituents, deemed it proper to acquire two (2) multi-purpose utility vehicles that will be utilized by the thirty (30) barangays;

WHEREAS, there are considerable number of underutilized assets and equipment in the MWSS that may be of further use to interested Local Government Units;

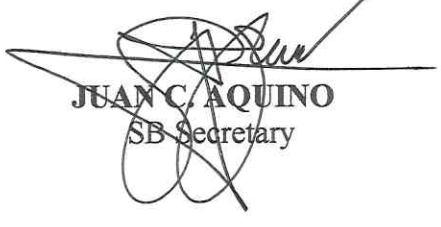

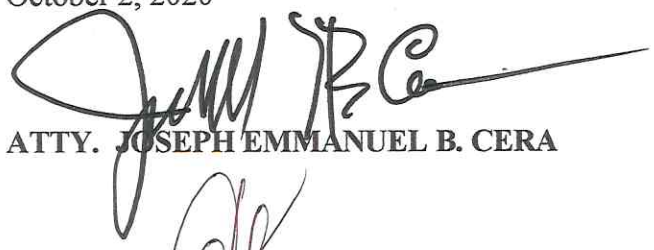
