RESOLUTION NO. 2020 - 194

RESOLUTION WITHDRAWING ORDINANCE NO. 2020-05 OTHERWISE KNOWN AS AN "ORDINANCE REQUIRING ALL PERSONS TO WEAR FACE MASK AND FACE SHIELDS AT ALL TIMES IN PUBLIC PLACES WITHIN THE MUNICIPALITY OF MANGALDAN, PANGASINAN DURING THE EFFECTIVITY OF THE COMMUNITY QUARANTINE TO ABATE THE SPREAD OF COVID-19, PROVIDING PENALTIES FOR VIOLATION THEREOF AND FOR OTHER PURPOSES".

WHEREAS, a proposed Ordinance requiring all persons to wear face mask at all times in public places within the municipality of Mangaldan, Pangasinan during the effectivity of the community Quarantine to abate the spread of covid-19, providing penalties for violation thereof and for other purposes was first calendared on August 20, 2020 and it was referred to the Committee on Health for appropriate action. Accordingly, procedures such as Committee Hearing and Public Hearing were conducted and satisfied;

WHEREAS, on September 11, 2020, the Sangguniang Bayan of Mangaldan, Pangasinan has enacted an Ordinance No. 2020-05 otherwise known as an "Ordinance requiring all persons to wear face mask and face shields at all times

in public places within the municipality of Mangaldan, Pangasinan during the effectivity of the community Quarantine to abate the spread of covid-19, providing penalties for violation thereof and for other purposes";

WHEREAS, the said Ordinance No. 2020-05 was submitted to the Office of the Municipal Mayor, Hon. Mary DG. Lambino for the latter's signature;

WHEREAS, while waiting for the document to be remanded back to the Office for completion and submission to the Provincial Board, the Sangguniang Bayan of Mangaldan, Pangasinan came to know on September 24, 2020 as evidenced by the acknowledgment receipt thru email dated August 10, 2020, the Sangguniang Panlalawigan enacted a Provincial Ordinance No. 242-2020, "AN REQUIRING PUBLIC COMMUTERS AND DRIVERS AND EMPLOYEES OF INCLUDING **OFFICES PRIVATE** AND GOVERNMENT COMMERCIAL ESTABLISHMENTS TO WEAR FACE SHIELD (ALONG WITH FACE MASK) WITHIN THE TERRITORIAL JURISDICTION OF THE PROVINCE OF PANGASINAN DURING THE PERIOD OF COMMUNITY QUARANTINE OR UNTIL LIFTED, AND PROVIDING PENALTIES FOR VIOLATION THEREOF;

WHEREAS, the Sangguniang Bayan of Mangaldan realized that the enactment of said Provincial Ordinance No. 242-2020 prior to the enactment of Sangguniang Bayan Ordinance No.2020-05 would in any way render the latter Ordinance in its futility taking into consideration the period of its enactment. Accordingly, the same Sangguniang Bayan deemed it proper to recall the said ordinance;

WHEREFORE, on motion of Councilor Dr. Joselito G. Quinto duly seconded by all the remaining members present:

RESOLVED as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan withdraws Ordinance No. 2020-05 otherwise known as an "Ordinance requiring all persons to wear face mask and face shields at all times in public places within the municipality of Mangaldan, Pangasinan during the effectivity of the community Quarantine to abate the spread of covid-19, providing penalties for violation thereof and for other purposes".

De Guzman, Audit Team Leader, the Office of the Municipal Mayor through Hon. Mary Marilyn DG. Lambino, and all other authorities concerned for their information.
