RESOLUTION NO. 2020 – 195

RESOLUTION APPROVING BARANGAY ORDINANCE NO. 1 S.
2020 OF THE SANGGUNIANG BARANGAY OF MALABAGO,
“AN ORDINANCE IMPOSING TAXES, FEES AND CHARGES IN
BARANGAY MALABAGO, MANGALDAN, PANGASINAN” AS

WHEREAS, the Sangguniang Barangay of Malabago submitted their


