RESOLUTION NO. <u>2020 – 195</u>

RESOLUTION APPROVING BARANGAY ORDINANCE NO. 1 S. 2020 OF THE SANGGUNIANG BARANGAY OF MALABAGO, "AN ORDINANCE IMPOSING TAXES, FEES AND CHARGES IN BARANGAY MALABAGO, MANGALDAN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BARANGAY TO ENACT.

WHEREAS, the Sangguniang Barangay of Malabago submitted their Ordinance No. 1, Series 2020 to the Sangguniang Bayan for review, evaluation and approval;

WHEREAS, pursuant to Section 447 (a)(1)(i) of RA No. 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Bayan as the legislative body of the Municipality review all ordinances approved by the sangguniang barangay and Executive Orders issued by the Punong Barangay to whether these are within the scope of the prescribed powers of the sanggunian and of the Punong Barangay;

WHEREAS, the Sangguniang Bayan conducted a committee hearing relative thereto with the attendance of the Sangguniang Barangay Officials and thoroughly reviewed and deliberated the said ordinance;
