RESOLUTION NO. 2020 - 196

RESOLUTION AUTHORIZING THE ENROLLMENT IN THE
PHILHEALTH ELECTRONIC PREMIUM REMITTANCE
SYSTEM (EPRS) WITH LANDBANK MANGALDAN, A
GOVERNMENT DEPOSITORY BANK, TO EFFECT THE
MANDATES OF THE UNIVERSAL HEALTH CARE ACT
AND THE EASE OF DOING BUSINESS AND EFFICIENT
DELIVERY OF GOVERNMENT SERVICES (EODB-EDGS)
ACT OF 2018.

WHEREAS, Article II, Section 15 of Philippine Constitution, provides that
the "State shall protect and promote the right of health of the people and instill
health consciousness among them";

WHEREAS, Republic Act 11223, otherwise known as the Universal Health
Care Act, hereby enforce an integrated and comprehensive approach to ensure that
all Filipinos are health literate, provided with healthy living conditions and
protected from hazards and risks that could affect their health;

WHEREAS, it ensures that Filipinos are guaranteed equitable access to
quality and affordable health care goods and services and protected against
financial risk;

WHEREAS, Philhealth unveils new website, now includes online services that range from electronic registrations, claims eligibility verification, and online mapping to electronic premium reporting and payment for employers;

WHEREAS, in the efforts to improve core business processes, the development of the Electronic Premium Remittance System (EPRS) was initiated, of which pertinent information can be viewed via the internet;

WHEREAS, the EPRS is a web-based application designed for Philhealth employers to use in reporting premium contributions;

WHEREAS, EPRS online payment aims to provide faster acknowledgement of premium payments and immediate posting of employers premium contribution, also resolve the prevalence of dishonored payment transactions and prolonged reconciliation status in the EPRS due to erroneous posting of payment information;

WHEREAS, it is an obligation of employers to remit the premium contributions of their employees, including their counterpart shares correctly on time, and accurately, as well as to report these remittances immediately so that the appropriate posting of contribution can readily be undertaken;

WHEREFORE, on motion of Councilor Atty. Fernando Juan A. Cabrera duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the enrollment in the Philhealth Electronic Premium Remittance System (EPRS) with Landbank Mangaldan, a Government Depository Bank, to effect the mandates of the Universal Health Care Act and the Ease of Doing Business and Efficient Delivery of Government Services (EODB-EDGS) Act of 2018;


