RESOLUTION NO. <u>2020 – 197</u>

ADOPTING RESOLUTION APPROVING AND SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 5, CY 2020 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN.

WHEREAS, as provided in the Joint Memorandum Circular No. 01-2007and JMC No. 1, 2016 of the Department of the Interior and Local Government (DILG), National Economic Development Authority (NEDA), Department of Budget and Management (DBM), and the Department of Finance (DOF), as well as the Updated Budget Operations Manual (UBOM) of the DBM, Local Government Units (LGUs) are mandated to support all supplemental budgets with their corresponding AIPs;

WHEREAS, in compliance to R.A 7160, particularly Section 106, otherwise known as the Local Government Code of 1991, the Municipality of Mangaldan sets to implement projects, programs and activities in the direction of economic and social development in the local government;

WHEREAS, this AIPs is an integral part of the Annual Local Government Planning and Budgeting System;

WHEREAS, this AIP is a tool by which a local government unit provides budgetary support to its Local Development Plan (LDP) and Development Investment Plan (LDIP) and translate the locality's development thrust into tangible programs and projects;

WHEREAS, the Municipal Development Council, Executive Committee convened a meeting and passed and approved Resolution No. 5, series of 2020 "Approving and Adopting the CY 2020 Annual Investment Program (AIP) supplemental No. 5 of the Municipality of Mangaldan, Pangasinan". The unexpended balances from previous appropriation to sustain responsiveness of local government service by improving social and health services, and pursuing operational effectiveness and efficiency of the organization to be made available through Supplemental Budget;

WHEREAS, the Local Chief Executive, Hon. Mary Marilyn DG. Lambino deemed it appropriate to implement priority programs, project and activities appurtenant to Officials and Employees and to the municipality in reciprocity to the effective, efficient and quality services we are rendering to the public;

WHEREAS, considering the significance of the priority programs, project and activities embodied in the Plan and understood to be in conformity with the thrust of the Local Government Unit of Mangaldan, Pangasinan contributing to the welfare of the general public, the Sangguniang Bayan felt the necessity to approve and adopt the resolution of the Municipal Development Council;
