INDORSING STRONGLY RESOLUTION DEPARTMENT OF BUDGET AND MANAGEMENT FOR FINANCIAL ASISTANCE AND SUPPORT IN THE AMOUNT OF P10,300,000.00 FOR THE PROCUREMENT OF VARIOUS VEHICLES AND EQUIPMENT/SUPPLIES FOR COVID-19 RELATED PROGRAMS, PROJECTS AND ACTIVITIES TO BE FUNDED UNDER THE LOCAL GOVERNMENT SUPPORT FUND-COVID-19 FINANCIAL ASSISTANCE (FA) TO LOCAL GOVERNMENT UNITS (LGSF-COVID-19 FA TO LGUs) IN THE BAYANIHAN TO RECOVER AS ONE ACT, R.A NO. 11494, TO WIT: 1) PROCUREMENT OF AMBULANCE (1 UNIT); 2) PROCUREMENT OF SERVICE VEHICLE (2 UNITS); 3) PROCUREMENT OF CONTAINER BINS (4 FEET); AND UNITS-20 FEET & 2 UNITS-40 PROCUREMENT OF BACK HOE (1 UNIT).

WHEREAS, Section 16 of the Local Government Code of 1991, under General Welfare Act, states that "every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of general welfare. Units shall ensure and support, among other things, the preservation and enrichment of culture promote health and safety, enhance right of the people to a balance ecology, encourage and support development of appropriate and self-reliant scientific and technological capabilities, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, the Municipal Government of Mangaldan, Pangasinan is apprised on the endeavor of the National Government in discharging its responsibilities in supporting every local government units in attaining its aspiration for a better quality service to the people;

WHEREAS, the Local Chief Executive, Hon. Mary Marilyn DG. Lambino identifies the necessity of the procurement of various vehicles and equipment/supplies for COVID-19 related projects, programs and activities to be funded under the Local Government Support Fund Financial Assistance to LGUs (LGSF-FA-LGUs);

WHEREAS, Republic Act No. 11494, Section 4(q), provides that the local chief executive s of all LGUs are hereby authorized to realign their respective local funds, including, but not limited to, their development fund, exclusively for financial assistance to local government unit in their local anti-COVID efforts;

WHEREAS, further, Department of Budget and Management Circular No. 128, provides guidelines and procedures on the release and utilization of the Local Government Support Fund – COVID-19 (LGSF-COVID-19) financial assistance to LGUs consistent with the "Bayanihan to Recover as One Act";

WHEREAS, procurement of said utilities promotes the interest of the public service which are necessary in the business operations or government transactions of front line agencies;

WHEREAS, Section 17 of R.A. 7160, otherwise known as the Local Government Code of 1991 provides: Basic Services and facilities. – (a) local government units shall endeavor to be self-reliant and shall continue exercising powers and discharging the duties and functions and responsibilities of national agencies and offices devolved to them pursuant to this Code. Local Government Units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate or incidental to efficient and effective provision of basic services and facilities;

WHEREFORE, on motion of Councilor Atty. Joseph Emmanuel B. Cera and duly seconded by all the remaining present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan strongly indorses to the Department of Budget and Management for financial assistance and support of P10,300,000.00 for the procurement of various vehicles and equipment/supplies for COVID-19 related Programs, Projects and Activities to be funded under the Local Government Support Fund-COVID-19 Financial Assistance (FA) to Local Government Units (LGSF-COVID-19 FA TO LGUs) in the Bayanihan to Recover as One Act, R.A. No. 11494, to wit: 1) Procurement of Ambulance (1 Unit); 2) Procurement of Service Vehicle (2 Units); 3) Procurement of Container Bins (4 Units-20 Feet & 2 Units-40 Feet); and 4) Procurement of Back Hoe (1 Unit);
