RESOLUTION APPROVING RESOLUTION NO. 21, SERIES OF 2020 OF THE SANGGUNIANG BARANGAY OF DAVID, MANGALDAN, PANGASINAN, ENTITLED "STRONGLY ENDORSING THE ANNUAL INVESTMENT PROGRAM (AIP) CY 2020 SUPPLEMENTAL NO. 2 FOR THE REVERSION OF FUNDS OF 20% DEVELOPMENT FUND, 5% OF GAD, EQUIPMENT SUPPLIES AND MOOE FOR CONSTRUCTION OF LUMINOUS LED STREETLIGHTS FOR BARANGAY DAVID, MANGALDAN, PANGASINAN IN THE AMOUNT OF ONE MILLION THREE HUNDRED FIVE THOUSAND THREE HUNDRED TWENTY FOUR **PESOS** AND 15/100 (P1,305,324.15).

WHEREAS, Section 447 (a) of the Local Government Code states that "the Sangguniang Bayan, as the legislative body shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipalities and its inhabitants pursuant to Section 16 of this code and in the proper exercise of the corporate powers of the municipalities as provided for under Section 22 of this Code";

WHEREAS, the subject Barangay Council Resolution No. 21, S. 2020, "Strongly endorsing the Annual Investment Program (AIP) CY 2020" is in relation to the two (2) resolutions that the Municipal Development Council passed;

WHEREAS, presented to this honorable body for legislative consideration and approval was the said barangay council resolution embodying the AIP for Calendar Year 2020;

WHEREAS, as mentioned under the Local Budget Circular No. 70 of the Department of Budget and Management stated that the AIP should include projects which are funded out of the development fund equivalent to not less than 20% of the local government unit internal revenue allotment;

WHEREAS, the members of the Sangguniang Bayan of Mangaldan, Pangasinan have thoroughly discussed and deliberated the programs, projects, and activities embodied in the AIP CY 2020 and was able to conclude that it is conform with the thrusts of the local government unit;

WHEREFORE, on joint motion of Councilor Atty. Joseph Emmanuel B. Cera and Councilor Christopher G. Romero duly seconded by all the members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan approves Resolution No. 21, Series of 2020 of the Sangguniang Barangay of David, Mangaldan, Pangasinan, entitled "Strongly Endorsing the Annual Investment Program (AIP) CY 2020 Supplemental No. 2 for the Reversion of Funds of 20% Development Fund, 5% of GAD, Equipment Supplies and MOOE for construction of luminous led streetlights for Barangay David, Mangaldan, Pangasinan in the amount of One Million Three Hundred Five Thousand Three Hundred Twenty Four Pesos and 15/100 (P1,305,324.15)";
