RESOLUTION NO. 2020 - 208

RESOLUTION APPROVING BARANGAY APPROPRIATION
ORDINANCE NO. 2, S. 2020 OF THE SANGGUNIANG
BARANGAY OF LANDAS, MANGALDAN, PANGASINAN,
ENTITLED "AN ORDINANCE ENACTING SUPPLEMENTAL
BUDGET NO. 2 CY 2020 OF THE GENERAL FUND
REALIGNING THE BUDGET FOR CULTURAL
PRESENTATION IN THE AMOUNT OF THIRTY THOUSAND
PESOS (P30,000.00) AS INDICATED IN THE ANNUAL
BARANGAY YOUTH INVESTMENT PROGRAM (ABYIP)
FOR FISCAL YEAR 2020 OF THE SANGGUNIANG
KABATAAN OF BARANGAY LANDAS INTO PROGRAMS,
PROJECTS AND ACTIVITIES RELATED TO EDUCATION
(OPLAN BALIK ESKWELA 2020)".

WHEREAS, pursuant to Section 17 of the 1987 Philippine Constitution "the
State shall give priority to education, science and technology, arts, culture and
sports to foster patriotism and nationalism, accelerate social progress, and promote
total human liberation and development;

WHEREAS, Ordinance No. 2, Series of 2020 of Barangay Landas was
submitted to this body for review, evaluation and approval;

WHEREAS, Section 447 (a)(1)(i) of Republic Act 7160, otherwise known as the Local Government Code of 1991, states that the “Sangguniang Bayan as the legislative body of the Municipality reviews all ordinances approved by the Sangguniang Barangay and Executive Orders issued by the Punong Barangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Punong Barangay”;

WHEREAS, a Committee Hearing was conducted by the Sangguniang Bayan with the presence of the Sangguniang Barangay Officials for a thorough review and deliberation of said Ordinance;

WHEREAS, upon exhaustive discussion and evaluation, the Sangguniang Bayan revealed that the subject ordinance is sufficient in form and substance. Further, it was determined that such action of the Sangguniang Barangay was within their conferred powers to enact such ordinance;

WHEREFORE, on joint motion of Councilor Atty. Fernando Juan A. Cabrera and Councilor Atty. Joseph Emmanuel B. Cera duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan approves Barangay Appropriation Ordinance No. 2, S. 2020 of the Sangguniang Barangay of Landas, Mangaldan, Pangasinan, entitled “An Ordinance Enacting Supplemental Budget No. 2 CY 2020 of the General Fund Realigning the Budget for Cultural Presentation in the amount of Thirty Thousand Pesos (P30,000.00) as indicated in the Annual Barangay Youth Investment Program (ABYIP) for Fiscal Year 2020 of the Sangguniang Kabataan of Barangay Landas into Programs, Projects and Activities related to Education (Oplan Balik Eskwela 2020)”;


