RESOLUTION APPROVING BARANGAY APPROPRIATION  
ORDINANCE NO. 2, S.2020 OF THE SANGGUNINAG  
BARANGAY OF NAVALUAN, MANGALDAN,  
PANGASINAN, ENTITLED "AN ORDINANCE ENACTING  
SUPPLEMENTAL BUDGET NO. 2 CY 2020 OF THE  
GENERAL FUND REPROGRAMMING THE BUDGET FOR  
SPORTS DEVELOPMENT AND YOUTH EMPOWERMENT  
AND CULTURAL ACTIVITIES ("LIBRENG GUPIT") IN THE  
AMOUNT OF FIFTY THOUSAND PESOS (P50,000.00) AS  
INDICATED IN THE ANNUAL BARANGAY INVESTMENT  
PROGRAM (ABYIP) FOR FISCAL YEAR 2020 OF THE  
SANGGUNIANG KABATAAN OF BARANGAY NAVALUAN  
INTO PROGRAMS, PROJECTS AND ACTIVITIES RELATED  
TO CORONA VIRUS DISEASE (COVID-19)".

WHEREAS, pursuant to Section 15 of the 1987 Philippines Constitution

WHEREAS, the Barangay Council of Navaluan, Mangaldan, Pangasinan has submitted its Supplemental Budget No. 2 for CY 2020 involving a total appropriation of Fifty Thousand Pesos (P50,000.00) which was approved through appropriation No. 2, S. 2020;

WHEREAS, the Committee of Appropriation and the Committee on Laws and Ordinances of the Sangguniang Bayan made an initial review and study on the said resolution and found out that the same was in order and in consonance with the submitted Supplemental Annual Investment Program of the barangay;

WHEREFORE, on joint motion of Councilor Atty. Fernando Juan A. Cabrera and Councilor Atty. Joseph Emmanuel B. Cera duly seconded by the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan approves Barangay Appropriation Ordinance No. 2, S. 2020 of the Sangguniang Barangay of Navaluan, Mangaldan, Pangasinan, entitled "An Ordinance Enacting Supplemental Budget No. 2 CY 2020 of the General Fund Reprogramming the Budget for Sports Development and Youth Empowerment and Cultural Activities ("Libreng Gupit") in the amount of Fifty Thousand Pesos (P50,000.00) as indicated in the Annual Barangay Investment Program (ABYIP) for Fiscal Year 2020 of the Sangguniang Kabataan of Barangay Navaluan into Programs, Projects and Activities related to Corona Virus Disease (COVID-19)";


