### RESOLUTION NO. <u>2020 – 213</u>

RESOLUTION APPROVING RESOLUTION NO. 1, SERIES OF 2020 OF THE SANGGUNIANG BARANGAY OF MALABAGO, MANGALDAN, PANGASINAN, ENTITLED "STRONGLY ENDORSING THE ANNUAL INVESTMENT PROGRAM (AIP) CY 2020 SUPPLEMENTAL BUDGET NO. 1 FOR THE REVERSION OF FUNDS OF 20% DEVELOPMENT FUND FOR THE PURCHASE OF DUMP TRUCK WITH TADANO FOR BARANGAY MALABAGO, MANGALDAN, PANGASINAN IN THE AMOUNT OF FOUR HUNDRED NINETEEN THOUSAND EIGHT HUNDRED NINETY FIVE PESOS AND 80/100 (P419,895.80) ONLY".

WHEREAS, par. (4) of Section 391 of R.A. 7160 of the Local Government Code, provides that "the sangguniang barangay shall provide for the construction and maintenance of barangay facilities and other public works projects chargeable to the general fund of the barangay or such other funds actually available for the purpose;

WHEREAS, it is the mandate of the Barangay Council of Malabago to provide its constituents with basic services and facilities pursuant to Section 17 of the same Local Government Code of 1991;

WHEREAS, Resolution No. 1, Series of 2020 of Barangay Malabago, Mangaldan, Pangasinan was submitted to Sangguniang Bayan for review, evaluation and approval;

WHEREAS, it was noticed that the numbering of the legislative measures of Barangay Malabago seems to be difficult to follow taking into consideration that the number of the subject resolution is just Resolution No. 1. Nevertheless, it was decided to respect the wisdom of the Barangay Council as to how they inscribe their legislative measures;

WHEREAS, pursuant to Section 447 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, "the Sangguniang Bayan, as the legislative body of the municipality, shall approve resolutions for the general welfare of its inhabitants pursuant to Section 16 of this Code";

WHEREAS, after scrutiny and careful study of the aforementioned resolution by the Sangguniang Bayan, the same were found to be in accordance with the budgetary regulations and is within the conferred powers of the Sangguniang Barangay to legislate;

WHEREFORE, on joint motion of Councilor Atty. Fernando Juan A. Cabrera and Councilor Atty. Joseph Emmanuel B. Cera duly seconded by the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan approves Resolution No. 1, Series of 2020 of the Sangguniang Barangay of Malabago, Mangaldan, Pangasinan, entitled "Strongly Endorsing the Annual Investment Program (AIP) CY 2020 Supplemental Budget No. 1 for the Reversion of Funds of 20% Development Fund for the purchase of Dump Truck with Tadano for Barangay Malabago, Mangaldan, Pangasinan in the amount of Four Hundred Nineteen Thousand Eight Hundred Ninety Five Pesos and 80/100 (P419,895.80) only";
