RESOLUTION NO. <u>2020 – 214</u>

RESOLUTION APPROVING BARANGAY APPROPRIATION ORDINANCE NO. 2, SERIES OF 2020 OF SANGGUNINAG BARANGAY MALABAGO, MANGALDAN, PANGASINAN ENTITLED,"AN ORDINANCE ENACTING SUPPLEMENTAL BUDGET NO. 1 CY 2020 OF THE GENERAL FUND FOR THE OPERATION OF LOCAL GOVERNMENT OF MALABAGO, MANGALDAN, PANGASINAN AND PROVIDING APPROPRIATION THEREOF".

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan of Mangaldan as a legislative body of the municipality is empowered to review ordinances authorizing annual or supplemental appropriation of barangay in the manner prescribed by law;

WHEREAS, the Barangay Council of Malabago, Mangaldan, Pangasinan has submitted its Supplemental Budget No. 1, for CY 2020 which was passed and approved by the Sangguniang Barangay thru Appropriation Ordinance No. 2, series of 2020;

WHEREAS, it was noticed that the numbering of the legislative measures of Barangay Malabago seems to be difficult to follow. Nevertheless, it was decided

to respect the wisdom of the Barangay Council as to how they number their legislative measure;

WHEREAS, the Committee on Appropriation and the Committee on Laws and Ordinances of the Sangguniang Bayan, have conducted initial review and study on said resolution and found out that the same is in consonance with the submitted Supplemental Annual Investment Program of the Barangay;

WHEREFORE, on joint motion of Councilor Atty. Fernando Juan A. Cabrera and Councilor Atty. Joseph Emmanuel B. Cera duly seconded by all the remaining members present;

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan approves Barangay Appropriation Ordinance No. 2, Series of 2020 of Sangguniang Barangay Malabago, Mangaldan, Pangasinan entitled, "An Ordinance enacting Supplemental Budget No. 1 CY 2020 of the General Fund for the operation of Local Government of Malabago, Mangaldan, Pangasinan and providing appropriation thereof";
