RESOLUTION NO. 2020 – 215

RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR,
HON. MARY MARILYN DG. LAMBINO TO ENTER INTO A
MEMORANDUM OF AGREEMENT (MOA) WITH THE
BUREAU OF SOILS AND WATER MANAGEMENT (BSWM)
REPRESENTED BY HON. SONIA M. SALGUERO,
DIRECTOR III, OFFICER-IN-CHARGE, BUREAU DIRECTOR
FOR THE TRANSFER OF FUNDS FOR THE
ESTABLISHMENT OF AGRO WASTE MANAGEMENT AND
COMPOSTING IN THE MUNICIPALITY OF MANGALDAN,
PANGASINAN.

WHEREAS, Section 25 of the Republic Act 7160 otherwise known as the
Local Government Code of 1991 provides for the intergovernmental relations
wherein the national government provide financial, technical or other form of
assistance to the local government units;

WHEREAS, Section 17 of the same Local Government Code of 1991
provides: Basic Services and facilities. – (a) local government units shall endeavor
to be self-reliant and shall continue exercising powers and discharging the duties
and functions and responsibilities of national agencies and offices devolved to them
pursuant to this Code. Local Government Units shall likewise exercise such other

powers and discharge such other functions and responsibilities as are necessary, appropriate or incidental to efficient and effective provision of basic services and facilities;

WHEREAS, the (BSWM) primary mandate is to ensure effective soil land, and water resources, utilization by undertaking projects and researchs on soil conservation, irrigation, and other related activities;

WHEREAS, the Local Government of Mangaldan has the capability to handle the establishment, operations and management of the Composting Facility for Biodegradable Wastes (CFBW);

WHEREAS, the transfer of funds for the for the establishment of Agro Waste Management and Composting in the Municipality of Mangaldan will surely redound to the welfare of the people of this town;

WHEREFORE, on motion of Councilor Christopher G. Romero duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes the Municipal Mayor, Hon. Mary Marilyn DG. Lambino to enter into a Memorandum of Agreement (MOA) with the Bureau of Soils and Water Management (BSWM) represented by Hon. Sonia M. Salguero, Director III, Officer-In-Charge, Bureau Director for the transfer of funds for the establishment of Agro Waste Management and Composting in the Municipality of Mangaldan, Pangasinan;


