## RESOLUTION NO. <u>2020 - 219</u>

RESOLUTION APPROVING BARANGAY ORDINANCE NO. 2, S. 2020 OF THE SANGGUNIANG BARANGAY OF MALABAGO, "AN ORDINANCE IMPLEMENTING R.A. NO. 9003 OTHERWISE KNOWN AS THE ECOLOGICAL SOLID WASTE MANAGEMENT ACT OF 2000 IN BARANGAY MALABAGO, MANGALDAN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BARANGAY TO ENACT.

WHEREAS, Section 10 of Republic Act 9003 otherwise known as the Ecological Solid Waste Management act of 2000, emphasize the vital role of the barangays in the successful implementation of the program, particularly in the segregation, collection and recycling of waste at source;

WHEREAS, DILG Memorandum Circular No. 2001-38 date April 10, 2001 directs the creation of the Barangay Ecological Solid Waste Management Committee in all barangays;

WHEREAS, the Sangguniang Barangay of Malabago, Mangaldan, Pangasinan submitted their Ordinance No. 2, S. 2020 to the Sangguniang Bayan for review, evaluation and approval;

WHEREAS, pursuant to Section 447 (a)(1)(i) of R.A. No. 7160 of Local Government Code of 1991, the Sangguniang Bayan as the legislative body of the municipality review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punong Barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the punong barangay;

WHEREAS, the Sangguniang Bayan conducted a committee hearing with the attendance of Barangay Officials and thoroughly reviewed and deliberated the said ordinances;

WHEREAS, the Sangguniang Bayan, after rigorous discussion and final evaluation finds the subject ordinance sufficient in form and substance and further determined that such action of the Sangguniang Barangay is within their conferred powers to enact such ordinance;

WHEREFORE, on motion of Councilor Atty. Fernando Juan A. Cabrera duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan approves Barangay Ordinance No. 2, S. 2020 of the Sangguniang Barangay of Malabago, "An Ordinance implementing R.A. 9003 otherwise known as the Ecological Solid Waste Management Act of 2000 in Barangay Malabago, Mangaldan, Pangasinan" as within the conferred powers of the Sangguniang Barangay to enact;
