RESOLUTION AUTHORIZING THE LOCAL CHIEF

MEJIA, TO APPLY WITH LANDBANK THE REACTIVATION
OF DORMANT ACCOUNTS OF THE MUNICIPALITY.

WHEREAS, Resolution No. 187, S 2019 was passed last October 17, 2019,


WHEREFORE, on motion of Councilor Atty. Fernando Juan A. Cabrera duly seconded by all the remaining members present:
