RESOLUTION NO. <u>2020 – 228</u>

RESOLUTION DECLARING THE SUPPLEMENTAL BUDGET NO. 01 FOR CY 2020 OF BARANGAY SALAAN, MANGALDAN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF THREE HUNDRED TWENTY NINE THOUSAND SEVEN HUNDRED TWENTY TWO PESOS AND 68/100 (P329,722.68) OPERATIVE IN ITS ENTIRETY.

WHEREAS, Section 384 of Republic Act No. 7160 of Local Government Code, provides, that as a basic political unit, the barangay serves as the primary planning and implementing unit of government policies, plans, projects, programs and activities in the community;

WHEREAS, endorsed to this Sanggunian for legislative action is Supplemental Budget No. 01 CY 2020 of Barangay Salaan, Mangaldan, Pangasinan;

WHEREAS, it provides under Section 333 of R.A. 7160 of the same Code, confers power to the Sangguniang Bayan to review barangay budget to ensure that the provisions of the Code on Local Fiscal Administration are complied with, which review power includes the authority to declare the same operative if it is ascertained that the appropriations contained therein exceed the estimates of the

income duly certified as collectibles, or that that same has not complied with the budgetary requirements set forth; and the authority to disallow the same if the items of appropriation are contrary to, or in excess of, any of the general limitations or the maximum amount prescribed;

WHEREAS, this Sanggunian finds that the aforesaid supplemental budget has satisfactorily met the budgetary requirements set forth under the Local Government Code of 1991, as certified by the Local Finance Committee, hence, declares the same operative and effective;

WHEREFORE, on joint motion of Councilor Atty. Joseph Emmanuel B. Cera and Councilor Atty. Fernando Juan A. Cabrera duly seconded by all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan declares the Supplemental Budget No. 01 for CY 2020 of Barangay Salaan, Mangaldan, Pangasinan involving a total appropriation of Three Hundred Twenty nine Thousand Seven Hundred Twenty Two Pesos and 68/100 (P329,722.68) operative in its entirety;
