## RESOLUTION NO. <u>2020 – 231</u>

RESOLUTION APPROVING BARANGAY RESOLUTION NO. 31, SERIES OF 2020 OF THE SANGGUNIANG BARANGAY OF MANGALDAN, PANGASINAN, **ENTITLED** BANAOANG, ANNUAL INVESTMENT "STRONGLY **ENDORSING** THE PROGRAM (AIP) CY 2020 SUPPLEMENTAL NO. 1 FOR THE REVERSION OF FUNDS OF PURCHASE OF VEHICLE, OFFICE SUPPLIES, TRAINING & SEMINARS, 5% GAD, BADAC, VAWC, TO PURCHASE OF LOT PROPERTY, CONSTRUCTION OF CANAL AND PURCHASE OF RELIEF GOODS FOR THE CONSTITUENTS OF BARANGAY BANAOANG, MANGALDAN, PANGASINAN IN THE AMOUNT OF ONE MILLION EIGHTY TWO THOUSAND 15/100 ONLY THREE HUNDRED SIXTY **PESOS** AND (P1,082,360.15)".

WHEREAS, pursuant to Section 16 of R.A. 7160, otherwise known as the Local Government Code of 1991, provides that, every Local Government Unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government unit shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balance ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance

economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, Section 384 of the same Code, mentioned, that as a basic political unit, the barangay serves as the primary planning and implementing unit of government agencies, plans, projects, programs, and activities in the community;

WHEREAS, Barangay Council of Banaoang has submitted its Resolution No. 31, Series of 2020 their Annual Investment Program (AIP) CY 2020 Supplemental No. 01 to Sangguniang Bayan for appropriate legislative action;

WHEREAS, the Sangguniang Bayan, as the legislative body, is empowered to enact ordinance, approve resolutions and authorizing annual or supplemental fund for the general welfare and in the manner prescribed by law, Section 447 (R.A. 7160);

WHEREAS, this Sanggunian finds the merit of the aforementioned Supplemental Budget of said Resolution of Barangay Banaoang and has satisfactorily met the budgetary requirements set forth under the law, as certified by the Local Finance Committee, hence, declares feasible and effective;

WHEREFORE, on joint motion of Councilor Atty. Joseph Emmanuel B. Cera and Councilor Atty. Fernando Juan A. Cabrera duly seconded by the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan approves Barangay Resolution No. 31, Series of 2020 of the Sangguniang Barangay of Banaoang, Mangaldan, Pangasinan, entitled "Strongly Endorsing the Annual Investment Program (AIP) CY 2020 Supplemental No. 1 for the Reversion of Funds of Purchase of Vehicle, Office Supplies, Training & Seminars, 5% GAD, BADAC, VAWC, to Purchase of Lot Property, Construction of Canal and Purchase of Relief Goods for the constituents of Barangay Banaoang, Mangaldan, Pangasinan in the amount of One Million Eighty Two Thousand Three Hundred Sixty Pesos and 15/100 only (P1,082,360.15)";
