RESOLUTION NO. 2020 – 251

RESOLUTION APPROVING AND ADOPTING THE
SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP)
NO. 6, CY 2020 OF THE MUNICIPALITY OF MANGALDAN,
PANGASINAN.

WHEREAS, the Department of Budget and Management has recommended
updating the policies on and level of incentives applicable to all government
personnel through the grant of a One-time Service Recognition incentive, to
recognize and further encourage the unwavering commitment/dedication in
performing their duties in the delivery of services to the public;

WHEREAS, the Municipal Development Council Executive Committee
convened a meeting last December 23, 2020 purposely to discuss the granting of
Services Recognition Incentive to the Officials and Employees of the Municipality
of Mangaldan, Pangasinan in reciprocity to the effective, efficient and quality
services we are rendering to the people;

WHEREAS, Section 4 (h) of Administrative Order No. 19 issued by the
Office of the President authorizes the grant of Incentives to reward an employee's
loyalty to government service and contributions to the agency's continuing viable
existence; incentives as rewards for exceeding agency financial and operational

performance targets to motivate employee efforts toward higher productivity and other existing benefits to be categorized by the DBM;

WHEREAS, the authority of the Local Chief Executive or the Presiding Officer of the Sanggunian concerned may, by ordinance, augment item in the approved Supplemental Annual Investment Plan and Supplemental Budget for the legitimate utilization of the savings of the municipality;

WHEREAS, considering the urgency of the programs, projects, and activities embodied in the Plan and understood to be in conformity with the thrust of the Local Government Unit contributing to the welfare of the officials and employees of the municipality, the Sangguniang Bayan felt the necessity to approve and adopt the resolution;

WHEREFORE, on motion of Councilor Atty. Joseph Emmanuel B. Cera duly seconded by all the remaining members present:




