RESOLUTION AUTHORIZING HON. MARY MARILYN DG.  
LAMBINO, MUNICIPAL MAYOR TO IDENTIFY PLACES TO  
BE DECLARED AS THE FIREWORKS DISPLAY ZONE  
DURING THE NEW YEAR'S CELEBRATION IN THE  
MUNICIPALITY OF MANGALDAN, PANGASINAN.

WHEREAS, Executive Order No. 28 signed by President Rodrigo R.  
Duterte, dated June 20, 2017 provides for the regulation and control of the use of  
firecrackers and other pyrotechnic devices;

WHEREAS, the use of firecrackers and other pyrotechnic devices during  
Christmas and other related events of personal, religious, cultural and national  
importance is already a Filipino tradition;

WHEREAS, firecrackers, fireworks and pyrotechnics are hazardous  
materials that may destroy our environment and can cause injuries, destruction and  
even death;

WHEREAS, in relation thereof, the Local Chief Executive are authorized to  
promulgate the necessary rules and regulations on firecrackers and other

pyrotechnic devices within their territorial jurisdiction in conformity with the national standard, rules and regulations;

WHEREAS, in the furtherance of public safety and order in so far as firecrackers, fireworks and pyrotechnic devices are concerned, there is a need to have a stricter policy to regulate the use and designate places for the display of said firecrackers, fireworks and pyrotechnic devices;

WHEREFORE, on motion of Councilor Atty. Joseph Emmanuel B. Cera duly seconded buy all the remaining members present:

RESOLVED, as it is hereby resolved that the Sangguniang Bayan of Mangaldan, Pangasinan authorizes Hon. Mary Marilyn DG. Lambino, Municipal Mayor to identify places to be declared as the Fireworks Display Zone during the New Year's Celebration in the Municipality of Mangaldan, Pangasinan;


