RESOLUTION NO. 2020 - 254

RESOLUTION APPROVING AND ADOPTING THE  
SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP)  
NO. 7, CY 2020 OF THE MUNICIPALITY OF MANGALDAN,  
PANGASINAN.

WHEREAS, Administrative Order No. 38 issued by His Excellency  
President Rodrigo Roa Duterte provides for the Grant of Gratuity Pay for the Fiscal  
Year 2020 to Contract of Service and Job Order Workers in Government.

WHEREAS, the Local Government of Mangaldan, Pangasinan is  
maintaining Fifty-Eight (58) Contract of Service personnel, Two Hundred Sixty-  
Four (264) Job Order Employees and Ten (10) Hired Services to augment the Two  
Hundred Four (204) Regular Employees of the municipality in the delivery of basic  
service to the people;

WHEREAS, the Department of Budget and Management has recommended  
to update the policies on and level of incentives applicable to all government  
personnel through the grant of incentives to the workers in government to  
recognize and further encourage the unwavering commitment/dedication in  
performing their duties in the delivery of services to the public;

WHEREAS, the Municipal Development Council Executive Committee convened a meeting earlier this morning of December 29, 2020 purposely to discuss the granting of Gratuity Pay for the Fiscal Year 2020 to Contract of Service, Job Order Employees and Hired Service Workers in Government. of the Municipality of Mangaldan, Pangasinan in reciprocity to the effective, efficient and quality services we are rendering to the people;

WHEREAS, the authority of the Local Chief Executive or the Presiding Officer of the Sanggunian concerned may, by ordinance, augment item in the approved Supplemental Annual Investment Plan and Supplemental Budget for the legitimate utilization of the savings of the municipality;

WHEREAS, considering the urgency of the programs, projects, and activities embodied in the Plan and understood to be in conformity with the thrust of the Local Government Unit contributing to the welfare of these Contract of Service, Job Order Employees and Hired Service Workers in Government, the Sangguniang Bayan felt the necessity to approve and adopt the resolution;


